6. Eligibility Rules – Punjab State Inter District Cricket Tournaments

- A) A player shall be eligible to play for a district:
 - i) Within whose jurisdiction the player is born (Birth qualification).

or

ii) Within whose jurisdiction the player has been residing (Residential qualification) for the last one year prior to the year of the tournament. The player should attach the documentary proof himself duly attested by the District Secretary for whom the player is playing for the first time on this qualification.

or

iii) Within whose jurisdiction the player is studying in a recognized school or college for the last one year prior to the year of the tournament. The player will have to provide a certificate signed by the Principal of the school/ college / Professional Institution. The certificate should contain the admission number and date of admission of that player in that institution. The certificate will be considered valid only if signed by the Principal of the institution. Any certificate signed on behalf of the principal will not be admissible.

Note: The school for the purpose of rule Clause 6 (iii) shall be the one affiliated to recognized boards like:-

- a) Punjab School Education Board (P.S.E.B.),
- b) Central Board of Secondary Education (C.B.S.E.),
- c) Indian certificate of Secondary Examination (I.C.S.E.)
- d) And the college for this purpose, shall be affiliated with one of the Universities of Punjab or Union Territory of Chandigarh.

In case a player is pursuing a course / degree as a regular student (not through correspondence) from a private but recognized university of Punjab Govt. Then he or she will have to produce a certificate containing the admission number and date of admission in that institution along with the details of the course he/ she is pursuing.

The certificate should be signed either by Vice chancellor / Registrar of the university if the course is being run in the campus or by the principal of the Institution if it is being run under that university.

Or

- iv) Within whose jurisdiction the player is serving continuously for the one year prior to the year of the tournament. The player will have to attach a certificate containing the following particulars:-
- 1) Name of the organization.
- 2) Nature of business/ work.
- 3) Financial turnover of company / office/business/ establishment for the year prior to the year of the tournament along with the number of employees.
- 4) Salary drawn (The particulars of salary receipt i-e by cheque then the cheque number and date. In case of online payment then the details of bank account where salary is credited.
- v) Special Permission:- In case a player in course of his/ her studies shifts from an educational institution of one District to another and does not acquire the one year prior admission qualification, the player may seek special permission from PCA which the Hony. Secretary after considering the genuineness of each case may grant.

Note 1.:- One year prior to the year of the tournament means for the tournament of year 2016-17 he or she must be residing or studying or serving in their respective districts on or before 1st April, 2015.

Playing Conditions – Rolling

After the first days play and on all subsequent days the ground in charge will sprinkle two cans of water of 15 ltr capacity each on the wicket between the popping crease in the presence of Match Referee/Senior umpire before putting the covers.

The Host Association shall not use a roller of more than 500 kg of weight for Punjab State Inter District Tournaments matches. Similarly, the umpires shall not allow the use of a roller of more than 500 kg if asked by the captains in between the innings.

Note:- The above experimental playing conditions will be in force up to 30th September,2016.

General Instructions:-

The Match Referee/ Senior Umpire is authorized to check all the papers before the start of the Match. In case of some unavoidable circumstances or valid reason the Match Referee / Senior umpire may allow the defaulting team to submit the documents at the earliest but not later than the last day of the schedule day of the match. In case the match ends early, the last day of the match would be considered the day the match finishes.

In case, the team fails to submit the requisite documents, then the defaulting team will be awarded zero points irrespective of the points earned by them and other team will retain the points earned by them.
