



REPORT OF THE HONORARY SECRETARY, PCA

Dear President, Colleagues and Members,

I am pleased to present 73rd Annual Report of the Association for the year 2020-21. The year under Report witnessed one of the worst tragedies in the form of Covid-19 Pandemic, which forced all of the humanity to be locked up in their houses. The Pandemic has also resulted into curtailment of cricketing activities of the BCCI as well as in the State Associations.

The first wave of Pandemic started receding in July/August and PCA has initiated short & selective coaching/practice activities for the Punjab Senior Players by taking all precautions including non-use of saliva, prohibition on spitting, not more than 2 players in one net practicing etc.

The Punjab Cricket Association started its cricketing activities throughout the State in the month of December, 2020 by associating with M/s Trident Group. Even in the face of adversity, the PCA and M/s Trident Group had organized Men's (Senior) T20 Tournament, Senior One Day Tournament, Under-19 years as well as Under-16 years Tournaments.

These Tournaments had provided much needed respite and practice to the Punjab Players before participation in the National Tournaments. The BCCI had announced National Tournaments for Senior Teams only after taking due safeguards including strict quarantine and bio-bubble.

The Punjab Senior Team participated in Senior T20 Tournament for Syed Mushtaq Ali Trophy and won all the league matches thus qualifying for Knock-out. However, while playing Semi-Finals against Baroda, the Punjab Boys lost the match and thus chances to win the Trophy.

The Punjab Senior Team then participated in the Inter State One Day Tournament but failed to qualify for knock-out. In the similar turn of the fate, the Punjab Women Team, who had participated in the Women Senior One Day Tournaments could not qualify for Knock-out stage of matches.

Even though the Season was too short to properly assess the performance of PCA Teams, I would like to share with the members that the Punjab Teams are working hard and the process being followed will help us to achieve the goal of winning the Ranji Trophy.

I would like to convey my thanks to the Presidents & Honorary Secretaries of the District Cricket Associations for assisting PCA in organizing the various Tournaments and Camps.

I would also like to inform that PCA has recently conducted the Vinoo Mankad Trophy 'A' Group Matches at Mohali, Mullanpur and Chandigarh successfully by creating bio-bubble. The CEO and his Team, who have created and maintained the bio-bubble and made arrangements including logistics need special mention. We place on record our appreciation and special thanks to CEO.

We would also like to convey our thanks to M/s Trident Group for providing Sponsorships and Cash Awards to Punjab Players and various District Players.

We also place on record our sincere thanks to Officials of the Association by working hard and to assist the Office Bearers and Members of the Apex Council for smooth functioning of the Association.

INTER STATE TOURNAMENTS 2020-21

Due to Covid-19 Pandemic, the BCCI had curtailed the National Cricket Season and organized only Men & Women Senior Tournaments. The Trident Group, even after crushing economic blows to the industry due to Pandemic, had offered the sponsorship of Rs.25 lacs for providing cricket kits to the Punjab Teams participating in the National Tournaments in addition to providing complete logistics, infrastructure and financial awards in conducting Domestic Tournaments.

The details of National Tournaments and participation of Punjab Teams are as under: -

Syed Mushtaq Ali Trophy (Senior T20)

Punjab played their first match against UPCA on 10 January 2021 at Alur 2 ground, Bengaluru. Punjab won the toss and opted to bat first. Punjab scored 134 for 7 in 20 overs. Prabshimran Singh 43 off 41 balls inclusive of 4 boundaries and 1 six and Anmolpreet Singh 35 off 27 balls with 2 boundaries and 2 sixes were the main run getters for Punjab. Bhuvneshwar Kumar 3 for 22 and Ankit Rajpoot 2 for 28 were the main wicket takers for UPCA. Replying UPCA was 123 for 5 in 20 overs and lost the match. Suresh Raina 56 off 50 balls with 2 boundaries and 3 sixes was the top run getter for UPCA. Siddharth Kaul 2 for 28 was the main wicket takers for Punjab. Punjab won their first league match of the Syed Mushtaq Ali trophy and got 4 points.

Punjab played their 2nd match against host team Karnataka. Punjab won the toss and choose to field first. Karnataka batting first scored 125 for 8 in 20 overs. Rohan Kadam 32 off 33 balls with 3 boundaries was the top run getter for Karnataka. Siddharth Kaul 4 for 26 and Arshdeep Singh 2 for 18 were the highest wicket takers for Punjab. Punjab in reply were able to reach the target in 14.4 overs for the loss of 1 wicket. Prabhsimran Singh 89 off 52 balls inclusive off 9 boundaries and 5 huge sixes was the top run getter for Punjab. Punjab was able to record their 2nd win in the tournament and got 4 points.

Punjab played their 3rd match against Railways at Alur, Bengaluru on 14 January 2021. Railways won the toss and elected to field first. Punjab batting first scored a 200 runs in 20 overs for the loss of 4 wickets. Abhishek Sharma 107 off 62 balls inclusive of 5 boundaries and 9 sixes and Prabhsimran Singh 63 off 39 balls studded with 2 boundaries and 4 sixes were the main run getters for Punjab. Railways in reply were bundled out for 83 in 17.1 overs. Harpreet Brar impressive spell of 4 for 22 and Arshdeep Singh 3 for 16 helped Punjab to record their 3rd consecutive win in the tournament. With this win Punjab got 4 points and remained on top in points tally.

Punjab played their 4th match against J&K at Alur 3, Bengaluru. Punjab won the toss and choose to field first. J&K batting first was able to score 139 for 8 in 20 overs. Subham Singh Pundir 42 off 34 balls with 3 boundaries and 2 sixes. Siddharth Kaul 4 for 33 and Harpreet Brar 2 for 22 were the main wicket takers for Punjab. Punjab in reply got the target and were able to score 140 without loss and able to record their 4th consecutive win and got 4 points. Unbeaten Prabhsimran Singh 73 off 46 balls with 4 boundaries and 6 sixes and Abhishek Sharma 59 off 42 balls with 4 boundaries and 4 sixes were the top run getters for Punjab.

Punjab played their last league match against Tripura at Alur, Bengaluru. Tripura won the toss and elected to field first. Punjab batting first were able to score 183 for 3 in 20 overs. Mandeep Singh 99 off 66 balls with 9 boundaries and 4 sixes and Gurkeerat Mann 63 off 33 balls with 3 boundaries and 6 sixes were the highest run getters for Punjab. Tripura in reply were 161 for 4 in 20 overs and lost the match. UU Bose 50 off 37 balls and unbeaten Milind 64 off 40 balls with 5 boundaries and 3 sixes were the highest run getters for Tripura. Punjab won all league matches of Syed Mushtaq Ali Trophy and topped the points table with 20 points and qualified for the quarterfinals at Ahmedabad.

Punjab played their quarterfinals against Karnataka at Narender Modi, Stadium Ahmedabad. Punjab won the toss and decided to bowl first. Batting first Karnataka were bundled out for 87 in 17.2 overs. Siddharth Kaul 3 for 15, Sandeep Sharma 2 for 17 and Arshdeep Singh 2 for 16 were the main wicket takers for Punjab. Punjab scored 89 for 1 in 12.4 overs. Prabshimran Singh 49 off 37 balls with 2 boundaries and 3 sixes were the main run getter for Punjab. Punjab qualified for semifinals.

Punjab played semifinals against Baroda at Narender Modi, Stadium Ahmedabad. Punjab won the toss and elected to field first. Batting first Baroda were able to scored 160 for the loss of 3 wickets. Kedar Devdhar 64 off 49 balls and KR Kakade 53 off 41 balls with 5 boundaries and 2 sixes. Punjab in reply were 135 for 8 wickets in 20 overs and lost the match. Gurkeerat Mann 39 off 37 balls with 3 boundaries and 1 six and unbeaten knock of Mandeep Singh 42 off 24 balls with 3 boundaries and 3 sixes were the main run getters for Punjab. Punjab failed to qualify for the finals.

Punjab played their inaugural match against Tamil Nadu at Emerald Cricket Ground, Indore. Tamil Nadu won the toss and choose to field first. Punjab batting first scored 288 for 4 in 50 overs. Gurkeerat Mann 139 off 121 balls with 14 boundaries and 7 sixes, Prabshimran Singh 71 off 84 balls inclusive of 4 boundaries and 3 sixes and Sanvir Singh 58 off 53 balls with 4 boundaries and 3 sixes were the main run getters for Punjab. Tamil Nadu in reply chased the target and scored 289 for 4 in 49 overs. N Jagdeesan 101 off 103 balls with 14 boundaries and 2 sixes, B Aprajith 88 off 115 balls with 11 boundaries and 1 six and Shahrukh Khan unbeaten 55 off 36 balls with 7 boundaries and 1 six were the main run getters for Tamil Nadu. Siddharth Kaul 2 for 47 was the main highest wicket taker for Punjab. Tamil Nadu got 4 points while Punjab got 0.

Punjab played their next game against Jharkhand at SS Commune Ground, Indore. Jharkhand won the toss and elected to bat first. Batting first Jharkhand were able to scored 217 for 9 in 50 overs. Utkarsh Singh 51 off 78 balls with 2 boundaries and 2 sixes and unbeaten Shahbaz Nadeem 45 off 40 balls with 5 boundaries and 1 six were the highest run getters for Jharkhand. Siddharth Kaul 3 for 44 and Mayank Markande 2 for 33 were the main wicket takers for Punjab. Punjab in reply were bundled out for 215 in 45.5 overs. Abhishek Sharma 56 off 48 balls inclusive of 9 boundaries and 2 sixes and Mandeep Singh 68 off 88 balls with 3 boundaries and 3 sixes were the main run getters for

Punjab. Varun Aaron, Rahul Shukla and Anukul Roy scalped 2 wickets each for Jharkhand. Punjab lost the match by 2 runs. Jharkhand got 4 points while Punjab got 0.

Punjab in their next match against Andhra at Emerald Heights School, Indore won the toss and choose to field first. Andhra, batting first, were bundled out for 175 in 48.1 overs. Siddharth Kaul 4 for 27 and Barinder Saran 3 for 29 were the main wicket takers for Punjab. Punjab in reply chased the target and scored 176 for 3 in 36 overs. Mandeep Singh 64* off 81 balls with 8 boundaries was the top run getter for Punjab. Punjab won the match and got 4 points. Punjab played their next game against Vidarbha at Holkar Stadium, Indore. Punjab won the toss and choose to field first. Batting first Vidarbha scored 290 for 6 wickets in 50 overs. FY Fazal 101 off 99 balls with 9 boundaries and 4 sixes, Ganesh Satish 78 off 82 balls with 7 boundaries and 1 six and AV Wadkar 63 off 53 balls with 4 boundaries and 2 sixes were the main run getters for Vidarbha. Siddharth Kaul 4 for 54 and Harpreet Brar 4 for 53 were the main wicket takers for Punjab. Punjab in reply scored 294 for 6 and got 4 points. Prabhsimran Singh 167 off 140 balls with 13 boundaries and 9 sixes was the highest run getter for Punjab. Punjab won the match by 4 wickets and got 4 points. Punjab played their last league match against MPCA at Holkar Stadium, Indore. MPCA won the toss and elected to bat first. Batting first MPCA scored 402 for 3 in 50 overs. Venketash Iyer 198 off 146 balls with 20 boundaries and 7

Women's (Senior) One Day Tournament

Punjab played their first game against Nagaland at Emerald Heights school ground, Indore on 13 March 2021. Nagaland won the toss and choose to bat first. Nagaland batting first were bundled out for 55 in 39.3 overs. Komalpreet Kaur 3 for 6, Harpreet Dhillon 2 for 12, Mehak Kesar 2 for 4 and Kanika Ahuja 2 for 11 were the main wicket takers for Punjab. Punjab in reply chased the target 7.6 overs (56 for no loss). Jasian AKhtar unbeaten 25 off 19 balls inclusive of 3 boundaries and 29 off 25 balls with 5 boundaries were the main run getters. Punjab won the match by 10 wickets and got 4 points while Nagaland got 0.

Punjab played the next match against Baroda at Holkar Stadium, Indore on 15 March 2021. Punjab won the toss and elected to bowl first. Batting first Baroda scored 201 for 5 in 50 overs. Amrita Joseph unbeaten 76 off 115 balls with 9 boundaries and Hrutu Patel 36 off 49 balls inclusive of 5 boundaries and 1 six were the highest run getters for Baroda. Mehak Kesar 2 for 31 was the highest wicket taker for Punjab. Punjab in reply were bundled out for 137 in 36.2 overs and lost the match by 74 runs. Kanika Ahuja 35 off 60 balls with 5 boundaries and Neelam Bisht 29 off 26 balls inclusive of 4 boundaries and 1 six were the highest run getter for Punjab. Punjab played their 3rd match against Kerala at Daly college

ground, Indore on 17 March 2021. Punjab won the toss and decided to field first. Kerala batting first were bowled out for 216 in 48.4 overs. Shani.T 50 off 66 balls inclusive of 8 boundaries and Minnu Mani 72 off 55 balls inclusive of 11 boundaries and 1 six were the main run getters for Kerala. Kanika Ahuja 4 for 38, Mehak Kesar and BN Meena scalped 2 wickets each for Punjab. Punjab in reply were 149 for 9 in 50 overs and lost the match by 67 runs. BN Meena 50 off 108 balls inclusive of 4 boundaries was the main run getter for Punjab. Jispa V Joseph and Sajana S scalped 2 wickets each for Kerala. Kerala with this win got 4 points while Punjab got 0.

Punjab played their 4th match against Mumbai at Emerald Heights School, Indore on 19 March 2021. Mumbai won the toss and elected to bat first. Batting first Mumbai were bundled out for 159 in 43.1 overs. Vrushali Bhagat 43 off 73 with 5 boundaries and Simran Shaikh 30 off 39 balls with 4 boundaries were the highest run getters for Mumbai. Kanika Ahuja 5 for 43 was the main wicket taker for Punjab. Punjab in reply were bundled out for 98 in 42.4 overs. Domestic Season 2020-21

The PCA Domestic Cricket Season was started with staging of Inter-District U-19 years Tournament and followed up with Triangular Series (Senior) consisting of Punjab XI (Best of Punjab), Punjab Red and Punjab Green Teams. The details of the PCA Tournaments staged during 2020-21 are as under:

Punjab State U-19 years Inter-District Tournament (One Day Limited Overs)

The Punjab Cricket Association had organized Under 19 years One Day Limited Overs Tournament from 19th February to 27th February, 2021. Twenty District Teams had taken part in the Tournament, which were divided into four group with five teams in each group. The Tournament was played with SG Test white balls and colored clothing. The final of the Tournament was played between Mohali and Jalandhar. Jalandhar won the Trophy.

The Trident Group had given cash prizes of Rs.10000/- to best performed players, who took 3 or more wickets or who scored 50, 100 runs and who caught 2 or more catches in a match. The Trident Group also gave away prizes to Man of

the Tournament, best fielder and Best All-rounder besides Man of the match award for each match.

Some of the top performers of the tournament in batting department were Anshul Negi from Mohali 234 runs in 5 matches. Arun Kalia from Jalandhar 174 runs in 5 matches, Aditya Partap of Jalandhar 170 runs in 3 matches, Mayank Gupta from Ropar 170 runs in 2 matches, Karmanpreet Singh from Ropar 105 in 2 matches, Rushil Srivastva 102 runs in 2 matches and Rajinder Devgun 102 runs in 5 matches. In bowling department Harshdeep Singh from Mohali 12 wickets in 5 matches, Krish Bhagat 10 wickets in 3 matches, Anshul Negi 9 wickets in 5 matches, Raghu of Hoshiarpur 7 wickets in 3 matches, Parinaazbir Singh 7 wickets in 3 matches, Ashish 7 wickets in 3 matches, Jashan Chechi of Ropar 7 wickets in 3 matches ,Rushil Srivastva of Mohali 7 wickets 5 matches were the top wicket takers in the tournament. Triangular Series (Senior)

PCA had organized Challenger Triangular Series One Day Limited Overs Tournament for Trident Cup from 15th March to 26th March, 2021 at Ludhiana, Amritsar and Hoshairpur. The top players of Punjab were divided into three teams i.e. Punjab XI (Best of Punjab), Punjab Red and Punjab Green. The tournament was played on double round robin basis. Top two teams played the finals on 25th March, 2021 at I.S. Bindra Cricket Stadium, PCA Mohali. The top performers in batting department were Abhijeet Singh of Punjab XI with total runs 421 in 7 matches, Prabhjot Singh of Punjab XI total runs 355 in 6 matches, Salil Arora of RED total runs 249 in 7 matches, Gitansh Khera of Punjab RED total 239 in

7 matches, Vishwapartap of Punjab RED total runs 232 in 5 matches and Ramandeep Singh of Punjab XI 229 runs in 7 matches were the main run getters in the tournament. Some of the top performer in bowling department were Abhinav Sharma of Punjab XI with 11 wickets in 7 matches, Gurnoor Brar of PCA Punjab XI with 8 wickets in 7 matches, Deepin Chitkara of Punjab RED with 7 wickets in 6 matches, Ikjot Singh of Punjab RED with 7 wickets in 6 matches and Abhishek Bajaj Punjab Red with 7 wickets in 4 matches were the main wicket takers in the tournament The draws of the Tournaments are attached as Annexure-II.

After the first wave of Pandemic when the whole world was

bruised and shattered due to lockdowns and its allied effects, The Trident Group had come forward for the promotion of the Game of Cricket and provided opportunities to State Cricket Players to do what they love most "Play Cricket". The Trident Group not only Organized the tournaments in association with PCA but also provided complete financial, logistic and infrastructure support and gave away cash prizes to the players.

The details of the Tournaments are as under: -

Trident Cup (T-20) - Ludhiana

Ludhiana District Cricket Association, an affiliate of PCA had organized Senior T-20Tournament for Trident Cup from 18th to 27th Dec 2020 at Hara Cricket Academy and GRD Cricket Academy, Ludhiana. The tournament was sponsored by

Trident Group. The tournament was played with SG Test white Balls and Colored Clothing. Top players of Punjab were divided into two teams i.e. Punjab Red and Punjab Blues. Rest of players took part from various district teams Amritsar, Patiala, Jalandhar, Ludhiana and two teams from two Zones of Punjab. Total 8 teams had participated in the tournament. The final was played between Punjab Red and Jalandhar which was won by Punjab Red team.

Report of the CEO, PCA -2020-21

Respected President, Office Bearers and Members,

I am honoured to present the report on PCA activities under taken during the year under report as CEO, PCA.

The Union Government of India announced the spread of Covid-19 Pandemic and the Nation-wide lockdown was imposed in the last week of March, 2020. These uncertain times required out of box thinking. The equilibrium has to be made between the critical works going on and to safe guard the physical and mental health of the Officials. The minimum staff required to carry on with the critical works like maintenance of the site, ground, electrical, statutory obligations etc. were assessed, staff was identified and deputed on rotation basis.

The District Administration through Deputy Commissioner S.A.S. Nagar, Mohali requested to assist in providing lodging arrangements for the Covid warriors in secure place. Accordingly, after approval from the worthy President and Honorary Secretary, the discussions were held with Deputy Commissioner, Mohali and PCA residential wing was designated for secure use of the Covid warriors as recommended by the District Administration. It further necessitated the need of House-keeping, Security, Maintenance, Sanitization etc on regular basis which were executed by PCA Team efficiently.

The period of lockdown was effectively utilised to carry on with the general cleansing of the PCA Stadium, maintenance of the equipements like DG Sets, RO water purifier, Air Conditioners, Lifts, Fire Alarms and periodical cleansing of the Restaurant which was closed due to Pandemic. Further, the major project of relaying irrigation system in the main ground was also undertaken and completed successfully.

The Association has taken due care to meet all statutory requirements including timely filing of GST Returns, TDS, Salaries, Vendor payments, ESIC, EPF etc. The details of submission of statutory filing during the month of April, May and June, the period under severe restrictions, are being shared for kind information of the members:

- Monthly GST 3B returns for the month of March 2020, April 2020 and May 2020 has been duly filed as per due dates under GST Act, as detailed below-:
 - GST 3B for March 2020- Filed on 19th April 2020 (Due date 20 April 2020)

 - GST 3B for May 2020- Filed on 20th June 2020 (Due date 20 June 2020)

 - TDS for the month of April 2020- Deposited on 7th May 2020 (due date 7th May 2020)
 - TDS for the month of May 2020- Deposited on 6th June 2020 (due date 7th June 2020)
- 3. PF/ESI has been deposited for the month of March 2020, April 2020 and May 2020 as per due dates under EPF/ESI Act as detailed below-:
 - PF/ESI for the month of March 2020 has been deposited on 17th April 2020 (due date extended due to Covid to 20th April 2020)

PF/ESI for the month of May 2020 has been deposited on 15th June 2020 (due date is 15th June 2020)

The office was also able to compile the reimbursement claims for Inter State Tournaments for the year 2019-20 and submitted the same to BCCI in the month of May, 2020 itself.

The PCA Officials and manpower engaged through contractors, were strategically deployed throughout lockdown/restrictions period, on rotation basis so as not to hinder any work. As welfare measure and to appreciate the efforts of the staff who have worked during these times, financial assistance was also provided.

The first wave started receding in August/September 2020 and we were able to provide practice facilities to the Indian/IPL players who wanted to practice, with regular sanitisation and fogging.

In the month of December, the PCA in Association with M/s Trident was able to stage Inter District Senior T-20 Tournament. The PCA was only State Cricket Association who had staged Inter District Tournaments, camps and practice matches before the participation of Punjab Teams in the Inter State Tournaments.

I would like to convey sincere thanks and gratitude to the worthy President, Office Bearers and Members of Apex Council which have motivated the CEO and his team, from time to time, to make it an eventful year even in the dark shadows of the Covid-19 Pandemic.

REPORT/MINUTES OF SENIOR TOURNAMENT COMMITTEE



Report/Minutes of The Senior Tournament Committee Meeting dated 3rd April, 2021

Item No.1: To discuss and take appropriate decision on the staging of tournaments and Rules of Reimbursement including hosting and participation subsidy.

The CEO informed the members that PCA has purposed the revised rules for reimbursement for Inter-District Tournaments and the same were forwarded to the members along with Agenda. He shared that PCA will now be reimbursing a lump-sum amount of Rs. 15,000 for 1-day match, Rs.20,000 for 2-day matches, Rs.25,000 for 3-day matches and Rs. 30,000 for 4-day matches. He further informed that the amount of Rs. 15,000 will consist of traveling allowance / providing of vehicles to the District Teams from their headquarters to the place of the match and back. Similarly, for two day matches the DA for 3 days is to be paid and so on.

Further the District Associations will also be responsible to make payment of Rs.250/- per head per day to the team and officials as dinner expenses for and match day(s) and one day before. Further, the receipts of payment of dinner allowance to the players are to be attached along with the reimbursement claim.

The President advised that Districts may start making digital payments to players & officials, which will eliminate the need for making physical receipts.

The Representative of Muktsar District Cricket Association requested to increase the dinner allowance to Rs.300/- instead of Rs.250/-, which can be catered to by the Districts from the increased subsidy of the match.

The President remarked that the Districts are at liberty to decide and disburse DA to players and officials between Rs. 250 to Rs. 300. However the minimum of Rs. 250/- per head per day has to be paid to the players.

The CEO informed that the teams staying at the venue of the match during Rest Day for their next match instead of returning to their Headquarters, such teams have to pay the meal allowance to the players and support staff on the prescribed rates for the Rest Day as they would be saving the same on travel from their District to the venue of the next match. He further shared that it will also provide rest and additional practice to the players. The proposal was appreciated and approved by the members.

The CEO informed that hosting subsidy has also been increased to Rs.50,000 for 1 day match, Rs.1,00,000 for 2-day matches, Rs.1,50,000 for 3-day matches and Rs.2,00,000 for 4-day matches.

The CEO further emphasised that as per new Rules the match fee shall be paid by the District Associations to the Umpires, Match referee, Selectors, Scorers etc from this year onwards instead of sending their bills to PCA. He shared that it will result into speedy settlement of bills as well as consolidation of expenses made by the District associations on the specific Tournament/Matches.

The Committee appreciated the efforts made by CEO and his Team and after detailed discussions, unanimously approved the revised Rules for reimbursement for Inter District matches as reproduced below: -

Reimbursement of Inter District expenses: -

The revised Reimbursement Rules for hosting/participation in Inter District Tournaments organized by PCA are detailed below: -

- a) To Visiting Teams (For Away Matches) (Participation Subsidy):
 - i) For one day match -Rs.15,000/- per match
 - ii) For two days match-Rs.20,000/- per match
 - iii) For three days match -Rs.25,000/- per match
 - iv) For four days match-Rs.30,000/- per match

The above amount is to be used by District Association to pay traveling allowance/vehicles provided to their Players and Officials (maximum 16) to the venue of the match & back and payment of minimum Rs.250/- per head per day for meeting dinner expenses (receipts to be attached).

The Association may claim the above subsidy at the end of the Tournament by submitting a certificate on the enclosed format duly signed by the Honorary Secretary and Honorary Treasurer of the concerned association.

Note: -

If the Team stays at the venue for Rest Day, the visiting team has to bear the expenses of meal allowance for rest day, which they have to spend on travel from their Home District to the Venue of the Match.

b) To Host Association (For Home Matches) (Hosting Subsidy): -

The District Cricket Association will be paid the fixed reimbursement for staging the matches as per details given below: -

i) For one day match -Rs.50,000/- per match (i.e. Meal Allowance- Rs.22,000/i.e.Rs.440 x 50 persons and Two Nights Stay for visiting Team- Rs.17,000/- i.e. Rs.500 x 15 x 2 days (double occupancy) & 1 Coach-Rs.1000 x 2 days and Ground Maintenance- Rs.3,000/- and For Stay of 4 Match Officials (1 Match Referee, 2 Umpires, 1 Scorer- Rs.8,000/- for two nights).

- ii) For two day's match-Rs.1,00,000/- per match
- iii) For three day's match-Rs.1,50,000/- per match
- iv) For four day's match-Rs.2,00,000/- per match

This payment will include lodging arrangements for the Visiting Team (Maximum 16 persons) & Match Officials, Catering to both the teams (50 persons) on match days at ground as per menu supplied by PCA and expenses for preparation of ground and marking.

The PCA will reimburse the claim on receipt of proper invoice along with claim form duly signed by the Honorary Secretary and Honorary Treasurer of the District Association.

In addition, the staging association will make the payment of TA, DA & Match Fee to Match Officials and Selectors on PCA approved rates. The Association may claim reimbursement by submitting the payment claims/vouchers to PCA.

Mr. Bharti Vij and Mr. Navdeep Singh requested that Umpires may also be paid traveling allowance for Car during the Inter District Matches. Mr. Ranjeev Sharma seconded their proposal.

The CEO informed that in the amended rules, the Umpiring fee and DA has been substantially increased. He further informed that as seen in the past, except Elite Panel Umpires, most of the Umpires travel by Public Transport.

The Committee discussed in detail and approved to reimburse car charges, as Travelling Allowance to Elite Panel Umpires only. Further the Elite Panel Umpires claiming Car charges have to certify the same along with raising their claim bill in the prescribed proforma mentioning all details along with supporting documents, as designed by the office from time to time.

Item No.2: To discuss and approve the Rules for providing ground equipment and cricket balls to the member District Cricket Associations.

The CEO informed the members that the PCA is already providing ground equipment and cricket balls to the member associations running the Regional coaching centres. He further informed that PCA will now also consider the ground equipment for the second ground developed by any member association after entering into MOU and having operational control on the ground for practice and staging of matches.

The CEO shared with members that same quantity of cricket balls will now be supplied to each member association running RCC (Men), as detailed below:

A) SG Tournaments – 4 Dozen Per Annuum which will be distributed in 2 instalments. (April – May and Sept.-Oct.) SG Club – 12 Dozen Per Annuum which will be distributed in 2 instalments (April – May and Sept.-Oct.)

Further the District associations running the women academy, as approved by PCA, will also get additional balls as detailed below:

B) SG Tournaments (5oz.) – 2 Dozen Per Annuum which will be distributed in 2 instalments (April – May and Sept.-oct) SG Club (5oz.) – 4 Dozen Per Annuum which will be distributed in 2 instalments (April – May and Sept.-oct)

The Honorary Treasurer informed that some of the Districts have not yet submitted their Balance Sheets/ Utilization Certificates for the last financial year even after repeated reminders by the PCA. He further informed that keeping in view the non-submission of required documents their Subsidy/ Grant-in-aid are pending for the previous years.

The President advised that we shall have a cut-off date after which the subsidy payable to Member Associations will elapse in case of non-submission of financial documents and raising of invoice. The CEO proposed that we may fix 25th April of each year as cut-off for each member association to provide Balance Sheet for the last financial year i.e. for the year 2019-20, the same should be submitted by 25th April, 2021 and raise invoices to claim subsidy, other-wise the claims for previous years will stand lapsed.

The members discussed and unanimously approved the above proposal.

The Members further discussed the Rules for providing ground equipment to the Member Associations along with their lifespan. After detailed discussions, the Committee approved as under: -

Item No.3: To discuss and approve the revised Rules and Regulations for the Inter-District Cricket Tournaments.

The CEO informed that proposed Rules & regulations for the Inter District Cricket Tournaments were circulated to the Members along with Agenda and requested for inputs.

The Committee discussed in detail and requested Members to give their comments in next 15 days to CEO. Further, the CEO was directed to forward a copy of the Rules & Playing Conditions to BCCI Panel Umpires/Match Referees of PCA with the request to discuss and update the Rules/Playing Conditions in line with the latest MCC/ICC Guidelines.

The Committee further authorized the CEO to get the booklet printed and share with all the stake holders.

Report of the Senior Tournament Committee and Technical & Coaching Committee

The Senior Tournament Committee and Technical & Coaching Committee in their Joint Meeting held on 31st August, 2021 has decided as under: -

- i) PCA shall make necessary arrangements for successful conduct of the National Tournaments allotted by BCCI. Further CEO along with Honorary Treasurer was authorised to take all financial and admin necessary actions.
- ii) Pitches and playing conditions to be improved at the Districts Headquarters.
- iii) To affiliate Schools/Colleges having facilities of Cricket Ground and Coaches through District Associations.
- iv) All District Cricket Associations should set up office at Registered place and engage professional Chief Principal Officer (CPO), who should be computer savvy and having knowledge of accounts. CPO would be responsible for managing the District Office and interacting/responding to the PCA communication in professional and time bound manner.
- v) Districts Cricket Calendar for Inter Distt Tournaments.
- vi) Revised Selection Procedure 20 Distt. divided in 4 Zones.

REPORT OF SENIOR SELECTION COMMITTEE



Report of Senior Selection Committee

Appointed as chairman senior selection committee on 30/4/2021 along with four other members Sh.Sapan Chopra, Karan Goel, Harminder Jugnu and Bablu Kumar. Each selector was allotted four districts of Punjab. Due to lockdown and pandemic restrictions, the selectors were not able to visit the allotted districts immediately. However once the lock down was over the program to visit the allotted districts was planned with CEO and after taking the permission the allotted districts were visited by the selectors in the month of July. During the visit of districts, the selectors watched the net sessions and training sessions of the players. The selectors also interacted with the districts secretaries, coaches, sports staff and players. The selectors discussed the demand of modern day cricket with the players and coaches. It was observed by all the selectors that there is enormous talent in Punjab. The districts are providing young cricketers practice regularly in their respective districts. It is pertinent to mention here that all the districts are very keen to improve their cricket facilities and are working on it so that the players can get more facilities to improve their game.

In the month of July the inter district T-20 tournament was held and selectors were allotted matches to watch the players performances. From the T-20 matches 48 boys from all the districts were picked for the camp cum matches, four teams were made from the selected 48 boys and matches were organized at PCA Mohali from 6th to 13th August where all the selected players were given equal chance in the matches to show their skills. All the selectors watched every match and players performance was observed. From these matches selectors picked the team of Rest of Punjab which played match against Kapurthala the winner of T-20 tournament, which was won by Rest of Punjab. After that Katoch Shield Tournament was held and the selectors were allotted matches to watch the players performance. Further 50 overs inter district tournament was also organized where again the selectors were assigned to watch the matches. From all the above mentioned tournament the selection committee selected 40 boys from all the districts and camp was organized at PCA Mohali under the supervision of new appointed head coach Mr. Surinder Bhave. Being a local selector I visited the camp regularly and watch the nets and training session of the players every day. I also took observation from the coach on each selected player. From these 40 selected boys four teams were made (two teams for matches on 12 &13 oct and two teams for matches on 15,16 &17 oct) to play practice matches against UT and Haryana for the upcoming T-20 Mushtaq Ali tournament.

As a chairman Senior Selection Committee, I observed that there is lot of talent in Punjab and can be nourished by giving more exposure to the players by playing practice matches with other states. Further, I would like to thank PCA for organizing various format tournaments, which were very well organized during the period of pandemic. It gave the selection committee opportunity to watch every player for different formats and their performances, which helps the selection committee to select the right player for a particular format.

I am sure with the number of tournaments organized by PCA with top facility, which gave every player opportunity to show his skills, the Punjab cricket will improve day by day.

Report of Junior Cricket Committee

The Members of Junior Cricket Committee were professionally engaged as decided by the PCA. The members of the Committee had visited various District Headquarters to witness their coaching facilities.

Further, each member was allotted a pool of Districts so as to keep tab on their activities and to provide cricket, wherever required.

The Members witnessed the Inter District Under-16 years, Under-19 years and Under-25 years matches as allotted to them. After the completion of the Punjab Domestic Cricket Season (Inter District Matches), it has been found that the upcoming Districts required to improve the infrastructure as well as availability of the Coaches.

We prepare the following improvements to be carried out: -

- 1. First of all to improve the cricket pitches which are very slow and dry.
- 2. Secondly spinners getting more chances than fast bowlers this is not healthy sign for Punjab. Cricket.
- 3. We need to make good and hard wickets especially green wickets in every district is very essential.
- 4. Skilled coaching staff are required badly in upcoming districts.
- 5. Zone wise academy ,fast bowlers academy, batsman academy and wicket keepers academy, spinners academy also required to improve the Punjab cricket because Punjab junior cricket was shining star in past .

REPORT OF WOMEN'S SELECTION COMMITTEE



Report of the Women's Selection Committee

All selectors visited their respective RCC centers every month. From the date of selection till today we have watched all the matches held.

It was for the first time that two Zonal teams from minor district were made (Zone-A, Zone-B)..

Four days camp was organised at Bhatinda and Hoshiarpur.

05 players from these team got selected in state camp.

Punjab state senior inter district tournament was conducted on 16-08-21 to 20-08-21. Total number of 08 teams participated in this tournament. It was 50 over's a side league bases at two venues Barnala and Amritsar. The final match was conducted at PCA stadium Mohali on 25-08-21. After that 29 players were selected for state camp. All the selectors watched all the matches.

Punjab state under 19 inter district tournament was conducted on 27-08-21 to 31-08-21. Total number of 08 teams participated in this tournament. It was 50 over's a side league basis at two venues Barnala and Amritsar. The final match was conducted at PCA stadium Mohali on 02-09-21. After that 26 players were selected for state camp. All the selectors watched all the matches.

PCA took the initiative and it was for the first time that finals of the Inter District tournament was held at PCA Stadium Mohali and teams were rewarded cash prize.

Under 19 camp and practice matches were held at Barnala on 05-09-21 to 10-09-21. All the selectors were present during the camp to analyst the performances of the players. The team was selected for all India under 19 tournaments at Jaipur from 20-09-21 to 18-10-21. Punjab team performs well in this tournament and team has qualified for the quarterfinals.

Suggestions:-

There should be match referee in all the tournaments conducted under PCA.

The parents of players should not be allowed to sit near the playing areas.

There should be qualified women coaches particularly in minor district like Gurdaspur, Bhatinda, Mansa, Ferozpur, Faridkot etc. We do have talent in these districts but parents are not interested to send their daughters in combined centres.

Ex women cricketers are interested in doing the coaching level. PCA should take the initiative of making it possible.

There should at least one centre in the main district which is only for women cricketers where they feel to practice (can be common for all ages group.).
