-Glass bottles, plastic bottles and cans should be banned. The use of plastic satchels for consumption of drinking water or paper glasses for soft drinks may be permitted.

- The all/any vendors appointed/contracted involved in sale of any product and/or packaged food and Packaged Commodities within the Stadium premises shall comply with the Legal Metrology Act 2009 and also Legal Metrology (Packaged Commodities) Rules 2011 including but not limited to ensuring that the vendors (i) sell the said Packaged Commodities at a price not greater than the Maximum Retail Price ("MRP") printed on the Packaged Commodities and (ii) do not sell Packaged Commodities with dual MRPs. All vendors are strictly instructed to ensure compliance with the aforesaid.

**Terms & Conditions:-**

1. The Service Provider should have experience of minimum 3 years in providing Catering Services during public events of this scale/ International events (copy of proof to be attached).
2. Turnover of Rs. 3.00 Crores in the last three financial years. (Copy of Returns for three years are to be attached)
3. The Service Provider should have requisite registration for EPF, ESI, Labour & GST etc. Copy of the last return of EPF/ESI showing the category-wise number of employees with EPF registration should be submitted along with quotation.
4. Bids will be submitted in two separate envelopes namely, "Technical Proposal Catering Rights" and "Financial Proposal Catering Rights" shall be sealed together in the third envelope super scribing Financial Proposal & Technical Proposal Catering Rights.
5. Multiple bids are not allowed by any vendor in one category.
6. Earnest Money Deposit of Rs.3,00,000/- (Rupees Three Lakhs only) in form of Pay Order/Demand Draft of a scheduled bank in favour of " Punjab Cricket Association" payable at Chandigarh to be attached with the quotation. Earnest Money will be forfeited if the successful bidder will not deposit Quoted amount by due date and the contract will be offered to next best bidder.
7. The Match (India Vs South Africa) shall be considered as "Played" even if One Ball is bowled and the Contract for Catering Rights is performed. PCA will not be liable to refund any amount on this account.

8. The Vendor has to take Insurance Cover for the event on his part to cover liabilities.
9. Earnest Money of the successful bidder will be returned after successful execution of the contract within 7 days of receipt of confirmation of the performance of contract from concerned Committee/Official monitoring the same.
10. The quotation/tender shall be duly filled, signed, stamped and submitted in the box placed at Main Security Gate No.1 by 11<sup>th</sup> September, 2019 before 11:00 A.M. The date and time for opening the Quotations will be intimated.
11. The Punjab Cricket Association (PCA), Mohali reserves the right to reject any or all applications/bids without assigning any reason whatsoever.
12. Any damage caused during the work to men or machine will be at the risk of contractor.
