**RESPECTFULLY SHOWETH:**

1. The present complaint is being filed in terms of Sub-Rule (2)& (3) of Rule 46 of the Memorandum and Rules and Regulations of Association (as revised up to 11.08.2019) against following persons: -

- i) Firozpur District Cricket Association having its Head Office at 8<sup>th</sup>, The Mall, Opposite Town Hall, Krishna Marg, Firozpur City-152002 through its Honorary Secretary.
- ii) Sh. B.K. Mehta son of Dr. H.C. Mehta, Mob. 8847305200, Former Honorary Secretary for Life (till 01.01.2017), Firozpur District Cricket Association having its Head Office at 8<sup>th</sup>, The Mall, Opposite Town Hall, Krishna Marg, Firozpur City-152002 and a self styled Honorary Secretary of Ferozpur District Cricket Association, 32, Kirti Nagar, Ferozpur City.

2. That '**Ferozepur** District Cricket Association' is an affiliate of Punjab Cricket Association and *inter alia*, it is in receipt of financial aid and reimbursements from Punjab Cricket Association. The official website of Punjab Cricket Association mentions '**Ferozepur** District Cricket Association' as one of its affiliates and recognized Districts Cricket Association of Punjab. The name of the '**Ferozepur** District Cricket Association'

is listed at Serial No. 16 in the list of Affiliated Districts Cricket Associations. A true copy of the information downloaded from the official website of Punjab Cricket Association as on 09.07.2021 is annexed herewith as **Annexure C -1**.

3. That the sum and substance of the present complaint is that the aforesaid persons impleaded in personal capacity are running 02 parallel District Cricket Associations for District Ferozpur, Punjab using same PAN Card having same number but with different names. The 02 District Cricket Associations for District Ferozpur with same PAN Number are mentioned as under: -
- i) **Ferozpur** District Cricket Association
  - ii) **Firozpur** District Cricket Association.
4. That as per the information received under Right to Information Act, 2005, the relevant extracts of Articles of Association of '**Ferozpur** District Cricket Association' submitted in o/o Registrar, Firms & Societies, Ferozpur on 11.05.2005 read as under: -

**OPENING STATEMENT:**

"ARTICLES OF ASSOCIATION OF FEROZPUR DISTRICT CRICKET ASSOCIATION.

Founder members of Firozpur District Cricket Association (hereinafter referred to as FDCA) whose names appear in Schedule A of these articles having DECIDED on this 17<sup>th</sup> Day of February 1987 to form FDCA."

**"AFFILIATION**

Firozpur District Cricket Association would be affiliated with Punjab Cricket Association and would be guided by its policies and abide by its decisions.

**HEAD OFFICE**

FDCA would have its Head Office at 8<sup>th</sup>, The Mall, Opposite Town Hall, Krishna Marg, Firozpur Cirty 152002.

**BANK ACCOUNTS**

FDCA would open and maintain account(s) with Nationalized or Scheduled Bank(s). The Authority to operate that account would be

given by the President with the consent of the Executive Committee.

**SUBSCRIPTIONS**

1. All Office Bearers of FDCA would pay annual subscription of Rs.200/- each.
2. All ordinary members of FDCA would pay annual subscription of Rs. 50/- each.

The amount of both these subscriptions would be reviewed in every AGM and alterations there into would be carried by simple majority.

5. That Sh. B.K. Mehta has signed the Adoption Note in the capacity of Lifetime Honorary General Secretary, but the stamp and seal is of another person who is also claiming to be Honorary Secretary of Ferozepur District Cricket Association. Therefore, from the date it had been decided to incorporate 'FDCA', a deliberate confusion was created with regard to its full form. 'FDCA' is though claimed to be 'Ferozepur District Cricket Association', but the Articles of Associations drawn and submitted in the office of Registrar, Firms and Societies is of 'Ferozepur District Cricket Association'.
6. That a layman can term the aforesaid deliberate act as a mere spelling mistake but for the reason that there are 02 PAN Cards

with same Number but different name of the Societies indicate that there is something more than what meets the eyes. In this regard, copies of PAN Cards with same number and same date of incorporation but having different name of the Societies namely; **Ferozpur** District Cricket Association and **Firozpur** District Cricket Association are annexed herewith as **Annexure C-2** and **C-3 respectively**.

7. That the complainant checked for the correctness of the PAN Card on the official website of Income Tax Department and has downloaded certain information. The characters fed into the system indicate that the PAN card is of an Association having 1<sup>st</sup> word with 08 characters. The word Firozpur has 08 characters and the word Ferozpur has 09 characters, thus, *prima-facie* it appears that the PAN Card is of **Firozpur** District Cricket Association and by committing an offence of apparent forgery, the said PAN card is also being used by 'Ferozpur District Cricket Association'. A true copy of the information downloaded from the official website of Income Tax Department is annexed herewith as **Annexure C-4**.
8. That further, the aforesaid Articles of Association were submitted for Registration alongwith an Affidavit dated 11.05.2005 sworn by Sh. R.M. Maini son of Sh. Kundan Lal (the then President) alongwith a Resolution dated 08.05.2005 drawn on a plan paper. However, in the set of documents, which form part of the records in the office of the Registrar, Firm and Societies, Punjab, another resolution is available, which had been allegedly passed on 12.06.2005 authorizing Sh. R.M. Maini to get the **Firozpur** District Cricket Association' "FDCA" registered. Thus, the affidavit and other documents had been prepared well in advance before even passing of the alleged resolution dated 12.06.2005. A true copy of the resolution dated 12.06.2005 is annexed herewith as

**Annexure C-5.** This is signed by Mr Inderjeet Saggar as Treasurer whereas Mr Ashok Manchanda was Treasurer on 12.06.2005 as per records.

9. That in a very strange and interesting manner, the said resolution has been passed stating that '**Firozpur** District Cricket Association', claimed to be affiliated with Punjab Cricket Association is authorising Sh. R.M. Maini and certain other persons for registration of the Society under the Registration of Societies Act. It is interesting to notice that in case the resolution dated 12.06.2005 is taken to be correct then prior thereto for the period 17.02.1987 till 12.06.2005, the **Firozpur** District Cricket Association was an unregistered body. The resolution dated 12.06.2005 had been passed on a Letter Head of **Firozpur** District Cricket Association, however, the Articles of Association are of '**Ferozpur** District Cricket Association'.
10. That be that as it may, on 26.07.2005, '**Firozpur** District Cricket Association' was issued a Registration Certificate bearing Endorsement No. FZR.1852 of 2005 and copy thereof is annexed herewith as **Annexure C-6**.
11. That from the records received under RTI, it transpires that on 16.06.2017 certain documents had been submitted in the office of the Additional Registrar, District Industries Centre, Ferozpur intimating about the General House Meetings of '**Ferozpur** District Cricket Association' held on 11.12.2016 and 01.01.2017. In the meeting dated 11.12.2016, contrary to the Articles of Association, the then Honorary General Secretary Sh. B.K. Mehta certified that a decision has been taken by '**Ferozpur** District Cricket Association' to open a Saving Bank Account with UCO Bank and Sh. Nitin Mehta was authorised to operate the Bank Account. Further, on 01.01.2017, Sh. B.K. Mehta resigned as Honorary Secretary of '**Ferozpur** District Cricket Association'. A

true copy of the covering letter dated 16.06.2017 alongwith resolution dated 11.12.20016 and 01.01.2017 are annexed herewith as **Annexure C-7** and **Annexure C-8** respectively. Copy of resignation of Sh. BK Mehta is not on record in office of Additional Registrar, Firms & Societies, Ferozpur though it is mentioned in letter submitted by Ferozpur DCA on 25.02.2020 by S. Nitin Mehta, Office Secretary. As per MoA, 15 days notice is required to convene General Body Meeting, but resignation of Sh. BK Mehta submitted in January, 2017 was accepted on 01.01.2017. Moreover, 75% of members were either present or represented through proxy has not been recorded.

12. That the records submitted in the office of Additional Registrar, Firms and Societies, Ferozpur seems to have been tampered with and in continuation of the apparent incorrect recording of the entire incident leading to resignation of Sh. B.K. Mehta, the complainant would refer to Annexure-A attached to the Articles of Association, which mentions name of Gurdip Singh & Anoop Kaura, whereas, as per the records, the aforesaid persons were taken as Ordinary Members to the General House on 24.06.2012 & 22.06.2014 respectively as per minutes of General Body Meetings and Annexure-A has origin and reference to 17.02.1987.
13. That thereafter, certain minutes of meeting held by '**Ferozpur Cricket Association**' have been submitted in the office of the Competent Authority, which is altogether a different entity than '**Ferozpur District Cricket Association**' and/or '**Firozpur District Cricket Association**'. All the minutes of meetings held by '**Ferozpur Cricket Association**' are annexed herewith as **Annexure C-9** collectively.
13. That thereafter, in the records, series of documents apparently drawn, executed and signed on the same date in purported compliance of Section 4 of Societies Registration Act, 1860 are

available and the entire compendium is annexed herewith as **Annexure C-10**. It is submitted that all the documents have been drawn in the name of '**Ferozpur District Cricket Association (Regd.)**' with its address as 32, Kirti Nagar, Ferozpur City. The documents have been submitted from 2006 onwards whereas, in the year 2005 (26.07.2005), it is '**Firozpur District Cricket Association**' which was granted Registration Certificate with its address as 8, The Mall, Opposite Town Hall, Krishna Marg, Ferozpur City, 152002.

14. That as per the records, on 24.10.2019, while referring to a communication dated 15.10.2019, a notice was issued by the Office of Additional Registrar-cum-General Manager, District Industry Centre, Ferozpur to 'FDCA', 32, Kirti Nagar, Ferozpur City. It is interesting to note that o/o Additional Registrar-cum-General Manager, District Industry Centre, Ferozpur did not have this address on record. In the said notice, the concerned official observed that he could find certain discrepancies in the records. It is submitted that on 15.10.2019, a list of members was submitted in compliance of Section 4 of the Societies Registration Act, 1860 and apparently, being in default for the last about 15 years, lists of Managing Body of FDCA from 2006 onwards were submitted only on 15.10.2019, which is evident from the fact that it is only the list of dated 15.10.2019 which bears receiving by a government official and the remaining lists from 2006 to 2018 are blank. It may kindly be kept into consideration that Sh. B.K. Mehta resigned as Honorary General Secretary only on 01.01.2017. A true copy of the notice dated 24.10.2019 bearing memo No. 1168 is annexed herewith as **Annexure C-11**.
15. That in response to the aforesaid show cause notice, Sh. Nitin Mehta, Office Secretary of '**Ferozpur District Cricket Association**' with its address as 32, Kirti Nagar, Ferozpur City responded,

whereas, the registered body is '**Firozpur** District Cricket Association' with its address as 8, The Mall, Opposite Town Hall, Krishna Marg, Ferozpur City, 152002. The '**Ferozpur** District Cricket Association' is a fictitious body and unfortunately, it is this Body, which is affiliated with Punjab Cricket Association, which is clear from its official website. In recent communications on 25.05.2021 to Punjab Cricket Association, FDCA has represented themselves as '**Firozpur** District Cricket Association' and new MoA along with new PAN card has been submitted. It is apparent that a wrong entity has been withdrawing financial and other aids from Punjab Cricket Association.

16. That in support, a Balance Sheet of Ferozpur District Cricket Association for the year ending on 31.03.2020 is annexed herewith as **Annexure C-12** and the details of its UCO Bank Account No. 09410210001462 (Mochi Bazar, Ferozpur) are annexed herewith as **Annexure C-13**. A perusal of the Balance sheet would show that the financial aid being disbursed by the Punjab Cricket Association is being availed by an unregistered body and the amount is being shown to be disbursed in favour of fictitious persons.
17. That the transactions of Punjab Cricket Association and that of '**Ferozpur** District Cricket Association' are required to be looked into. In this regard, both '**Ferozpur** District Cricket Association' and '**Firozpur** District Cricket Association' should be called upon to explain their existence and the extent of benefits they have availed from Punjab Cricket Association.
18. That the role of the persons named hereinabove in their individual capacity requires a detailed inquiry by this Hon'ble Court. It is submitted that complete records including Bank Account details and registered Association of Articles of '**Ferozpur** District Cricket Association' and '**Firozpur** District Cricket Association'

documents submitted for getting both PAN cards should be summoned.

19. That the complainant prays for proper inquiry against the aforesaid persons in terms of Sub-Rule (2)& (3) of Rule 46 of the Memorandum and Rules and Regulations of Association and declare and award following penalties and punishments to the aforesaid persons: -

**INTERIM RELIEF/DIRECTIONS:**

- i) The original bank accounts statements alongwith bank account opening forms with original account opening dates and documents submitted for getting both PAN cards be summoned forthwith;
- ii) The CEO, Punjab Cricket Association be directed to immediately take steps for freezing of all the bank accounts of '**Ferozpur** District Cricket Association' and '**Firozpur** District Cricket Association';
- iii) The conflict of interest as intractable and thus, the Life Membership of the aforesaid persons be immediately suspended as interim relief/measure so that they do not interfere in free and fair inquiry process;
- iv) Further, during the pendency of the inquiry all further grant-in-aids/reimbursements be ordered to be immediately stopped/suspended and affiliation of 'Ferozpur District Cricket Association' (unregistered body) be immediately suspended;

**FINAL RELIEF**

- i) The aforesaid persons be completely barred for life from involvement with the game of Cricket;

- ii) Affiliation of 'Ferozpur District Cricket Association' (unregistered body) by Punjab Cricket Association be cancelled;
- iii) Suitable monetary penalty be imposed against the aforesaid persons of recovery of embezzled amount and restitution of all monetary benefits illegally availed by them be ordered;
- iv) Any other suitable penalty be imposed against the aforesaid persons in addition to the relief prayed hereinabove including for a direction to the Apex Council/its CEO to file a proper criminal complaint to the law enforcement agencies and/or file a recovery suit in accordance with law to recover the amounts/grant-in-aids/reimbursements made by Punjab Cricket Association etc. illegally siphoned off/embezzled by the aforesaid persons along with responsible office bearers of Punjab Cricket Association who were part of illegal acts and to represent themselves as Affiliated body of Punjab Cricket Association and participation of their Cricket Teams under various categories as District Cricket Teams.
