Offers are invited from experienced reputed companies/firms for providing food items Nonalcoholic Beverages, snacks in Spectator areas including Pavilion/Terrace during India Vs Afghanistan 1<sup>st</sup> T20 International Cricket Match to be played on 11th January, 2024 at PCA, I.S. Bindra Stadium, SAS Nagar, Mohali. **Interested parties may bid with earnest money of Rs. 1,00,000/- (Rupees One Lakh Only) through Demand Draft in favour of 'Punjab Cricket Association' on or before 28<sup>th</sup> December, 2023 at PCA by 1700 hours.**

- The all/any vendors appointed/contracted involved in sale of any product and/or packaged food and Packaged Commodities within the Stadium premises shall comply with the Legal Metrology Act 2009 and also Legal Metrology (Packaged Commodities) Rules 2011 including but not limited to ensuring that the vendors (i) sell the said Packaged Commodities at a price not greater than the Maximum Retail Price ("MRP") printed on the Packaged Commodities and (ii) do not sell Packaged Commodities with dual MRPs. All vendors are strictly instructed to ensure compliance with the aforesaid.
- Glass bottles, plastic bottles and cans will not be allowed in Stands. The use of plastic satchels for consumption of drinking water or paper glasses for soft drinks may be permitted.

**Terms & Conditions: -**

1. The Service Provider should have experience of minimum 3 events in past five financial years for providing Concessionaire Services during public events of this scale/ International events (copy of proof to be attached).
2. Minimum turnover of Rs. 50.00 lakhs in any one financial year and combined turnover of more than Rs. 2.00 Crores in the last Five financial years. (A Chartered Accountant certificate mentioning turnover of last five financial years is to be attached).

3. The Service Provide should not have been blacklisted/debarred by the BCCI/ State Association Or any Statutory Authority and an undertaking has to be provided alongwith Technical proposal in this regard.
4. Bids will be submitted in two separate envelopes namely, "Technical Proposal Concessionaire Services" and "Financial Proposal Concessionaire Services" shall be sealed together in the third envelope super scribing Financial Proposal & Technical Proposal Concessionaire Services addressed to the **CEO, PCA, Mohali** and shall reach **PCA Office** before **1700 hours on 28<sup>th</sup> December, 2023.**
5. Multiple bids are not allowed by any vendor in one category. The bidders have to submit the financial bid alongwith list of branded/reputed products proposed to available during the event.
6. Earnest Money Deposit of Rs. 1,00,000/- (Rupees One Lakh only) in form of Pay Order/Demand Draft of a scheduled bank in favour of " Punjab Cricket Association" payable at Chandigarh to be attached with the Technical proposal. Earnest Money will be forfeited if the successful bidder will not deposit the Quoted/Bid amount within three days of allotment of Contract and the contract will be offered to next best bidder.
7. The Earnest Money of non-successful bidders will be refunded after 7 days of declaration of successful bidder and in receipt of written request.
8. The Earnest Money of successful bidders will be treated as Security deposit and will be returned after successful execution of the contract within 7 days of receipt of confirmation of the performance of contract from concerned Committee/Official monitoring the same.
9. The successful bidder has to deposit full bid amount, in addition to earnest money already deposited, within 3 days from receipt of communication from PCA announcing offer of Contract.
10. The Match (India Vs Australia) shall be considered as "Played" even if One Ball is bowled and the Contract for Concessionaire Services is performed. PCA will not be liable to refund any amount on this account.
11. The Vendor has to take Insurance Cover for the event on his part to cover liabilities. Moreover, the PCA would not be responsible for any deficiency in services of the vendor including the public liability for above Concessionaire Services. The successful bidder is solely responsible for any deficiency of services including the quality of food/beverage items supplied and indemnify PCA for any public claim, if any.
12. The quotation/tender shall be duly filled, signed, stamped and submitted in the box placed at **PCA Reception** by **28<sup>th</sup> December, 2023** before **1700 hours**. The date and time for opening the Quotations will be intimated.

13. The Punjab Cricket Association (PCA), Mohali reserves the right to withdraw, reject any or all applications/bids without assigning any reason whatsoever.
14. Any damage caused during the work to men or machine will be at the risk of contractor.
