

Detailed Terms and conditions for Sale of Scrap Items like PVC, Plastic Shells, MS Steel Frame chairs and square pipe, MS Shutters, Wooden, Glass in PCA, I.S BINDRA, International Cricket Stadium, Mohali

1. The Details of Scrap material given as under:

2. The following are the important timelines:-

- a) The Interested parties may visit PCA, Mohali at **3.00 PM on 28th March, 2023** and the Manager, Maintenance, PCA will show all the scrap items to all the representatives. Before the start of the Auction process, the interested parties must submit an Earnest Money deposit in the form of Cash Deposit or Demand Draft of **Rs.20,000/- in favour of Punjab Cricket Association, payable at Mohali**. It is for the information of all the parties that the Bidder cannot participate in the auction process unless they submit the above Earnest Money to PCA before the start of auction process.
- b) The Auction process starts at **3.30 P.M on 28th March, 2023**. The minimum bid for the above items is **Rs.1,30,000/-**. The bid must be in the multiples of rupees in thousands. The items will be sold to only one vendor who has quoted the highest price, in totality, for the above

scraps. For the clarification purpose, only one bid has to be given by vendor for whole scrap.

- c) The **GST @18%**, in addition to the bid price quoted by the vendor during the auction, will be paid by the Scrap dealer as extra as per the invoice raised by PCA. The highest bidder must submit their full details including GST number, if any, to PCA immediately.
 - d) The Highest bidder of Auction process must deposit the amount along with GST charged by PCA through RTGS/NEFT immediately. Failure to deposit the above amount will lead to forfeiture of above earnest money of Rs.20, 000/-. The Earnest Money of unsuccessful bidders will be returned to the bidders **on 29th March, 2023 at 3.00 PM.**
 - e) All the scrap items must be lifted from PCA Stadium by **29th March at 3.30 PM.** Failure to fulfill the above clause will lead to **forfeiture of above Earnest Money deposit of Rs.20,000/-.**
3. The bidder must have PAN No.
 4. The Punjab Cricket Association reserves the right to reject/cancel the Auction process without any reason.
 5. Any damage caused during the work to men or machine will be at the risk of contractor.
 6. If the successful bidder fails to fulfill the obligations within the above time frames mentioned, then PCA has the right to approach the second highest bidder.
 7. The GST number of PCA is **03AAATP3502C1ZD**
 8. In case of any dispute arising between the parties, the CEO PCA will be the final authority to decide.
