TERMS & CONDITIONS

1. The contractor should have experience of executing the similar works with high standards (proof attached).
2. The bid should contain the copy of Registration certificate with GST and Pan no.
3. The rates are to be quoted item wise and rate/amount shall be all inclusive of all statutory Govt. Levies, as per Annexure "A" and "B" enclosed.
4. Multiple bids are not allowed by any vendor in one category.
5. Earnest Money Deposit of Rs. 10,000/- (Rupees Ten Thousand only) in the form of Pay order/Demand Draft of a schedule bank in favour of "Punjab Cricket Association" payable at Mohali to be attached with the quotation. Earnest Money will be forfeited if contractor will not take up the work in 2 days after receipt of orders.
6. The Earnest Money will be returned to the unsuccessful bidders within 15 days after the receipt of request letter. The earnest money of successful bidder will be retained for 6month as security money.
7. The quotation shall be duly filled, signed, stamped and submitted in the box placed at Main Security gate No.1 by 10th Feb., 2018 before 11:00 A.M. The date and time for opening the quotation will be intimated.
8. The payment will be made as per actual measurements on the approved rates. Any variation of the exceeded quantity, the contractor will take prior approval of the engineering-in-charge to execute the work.
9. The company will responsible for ESI and EPF etc. on labour part.
10. All the design specifications will be submitted/discussed with PCA before execution of work.
11. The work would be completed within 30 days from the date of receipt of work order failing which a penalty of Rs. 1, 000/- per day will be imposed.
12. The Punjab Cricket Association reserves the right to reject the damaged material or supplies if not up to the specifications.
13. Any damage caused during the work to men or machine will be at the risk of contractor.
14. The contractor/supplier should not depute any nominated sub-contractor.
15. If the project will not be completed within the stipulated time frame PCA has the right to complete the job from another agency with risk and cost of the company.
16. Adhoc payment, maximum up to 60% of the total work, may be made as per submission of Bill plus GST after verified by PCA Authority and balance plus GST after completion of work with proper invoice and certified by PCA authorities.
17. If the single Quotation exceeds the estimated cost, the quotations will be recalled.
18. In case of any dispute arising between the parties, the President PCA will be the final authority to decide.
