Harbhajan Singh, Ex-India cricketer in consonance with clause 5(b) of the Constitution of the Association. The minutes of meeting of the Life Membership Committee dated 02.10.2022 are annexed here with as Annexure R-5.

As it is abundantly clear from the perusal of the relevant extract of minutes of the Apex Council as reproduced above and the thread of the meeting of the Life Membership Committee as held on various occasions, the criteria to enrol Life Members to the Association was laid down by the Apex Council. The Life Membership Committee was only executing the task delegated to it by the Apex Council.
