TERMS & CONDITIONS

1. The contractor should have experience of executing the similar works with high standards.
2. The bid should submit the copy of Registration certificate with GST and Pan no along with the Technical Bid.
3. The rates except GST are to be quoted item wise and rate/amount shall be all inclusive of all statutory Govt. Levies, as per Annexure "A" enclosed.
4. Multiple bids are not allowed by any vendor.
5. Earnest Money Deposit of Rs. 10,000/- (Rupees Ten Thousand only) in the form of Pay order/Demand Draft of a schedule bank in favour of "Punjab Cricket Association" payable at Mohali to be attached with the quotation. Earnest Money will be forfeited if contractor will not take up the work in 2 days after receipt of orders. Security money amounting to Rs. 50,000/- in shape of Demand draft or Cheque Good for Payment in favour of "Punjab Cricket Association" and same D.D/cheque will be returned after retuning of the Barricades/Channels in good condition seven days after completion of Match.
6. The Earnest Money will be returned to the unsuccessful bidders within 15 days after the receipt of request letter. The earnest money of successful bidder will be retained till completion of work.
7. The quotation shall be duly filled, signed, stamped and submitted in the box placed at Main Security gate No.1 by 27th Feb., 2019 before 03:00 P.M. The date and time for opening the bids will be intimated.
8. The payment will be made as per actual measurements on the approved rates. Any variation of the exceeded quantity, the contractor will take prior approval of the engineering-in-charge to execute the work.
9. The company will responsible for ESI and EPF etc. on labour part.
10. All the execution of work to be done as per the direction of Police authority and gate management committee.
11. The installation of Barricading and Channel barricading work would be completed 2 day before the Match and remove the same immediate after completion of the Match.
12. The Punjab Cricket Association reserves the right to reject the damaged material or supplies if not up to the specifications.
13. Any damage caused during the work to men or machine will be at the risk of contractor.
14. The contractor/supplier should not depute any nominated sub-contractor.
15. If the project will not be completed within the stipulated time frame PCA has the right to complete the job from another agency at the risk and cost of the company.
16. 100% Payment will be done after completion of work with proper Bill/invoice and certified by PCA authorities.
17. If PCA receive only single Quotation and it exceeds the estimated cost, the quotations will be recalled.
18. In case of any dispute arising between the parties, the President PCA will be the final authority to decide.
