PRIVILEGES OF ASSOCIATE MEMBER

1. An Associate Member is eligible to apply for full membership of Punjab Cricket Club and his application for membership shall be considered as per the rules of the Punjab Cricket Club.
2. The Associate Member would be entitled for two concessional Tickets for VIP Block adjacent to main Pavilion for all the Matches under gate in accordance with the decision of the Executive Committee of Punjab Cricket Association on Match to Match basis. In addition, Members will have the entitlement to buy four tickets of any denomination (The Members will have to give their demand one week before the start of sale of tickets for public).
3. Keeping in view the contribution of the Associate Member towards the promotion and development of the game of Cricket, the Association may decide to promote him/her as Life Member of the Association, on such terms and conditions, as may be decided by the Executive Committee of the Punjab Cricket Association, from time to time.
4. Subject to availability and suitability, Associate Member may be allowed to use facilities such as tennis, fitness centre and cricket coaching facilities for himself/herself and dependents on payment of prescribed charges.
5. An Associate Member shall be entitled to the rebate of Rs. 5000/- or such rebate as decided by the Committee from time to time on the booking/ use of banquet/ conference facilities in the PCA stadium.
