



Complaint for taking strict appropriate action against the office bearers of the District Cricket Association, Sri Muktsar Sahib for conflict of interest, unfair practices, favoritism, prioritizing and biased approach towards their own wards, relatives and forfeiting the right of the deserving players and for de-affiliation of the District Cricket Association, Sri Muktsar Sahib.

AND

It is further prayed that strict legal action be taken against the respondent No. 5 being the Coach of the District Cricket Association for harassing the minor players mentally as well as physically by abusing, beating them to such an extent that they are forced to quit the game due to his such unethical and inhuman treatment and for conflict of interest by selling the cricket equipment under his name and forcing the players to purchase all the sports equipment from his shop GSM Sports Hub bearing logo "GSM" and for selling sports apparels

with the GSM logo as well as copied logo of PCA. and also providing private coaching to the players by charging hefty amount and selecting them over the regular players.

AND

With a further prayer that for taking strict legal action against the respondent No. 2-Secretary of the District Cricket Association for adopting corrupt and unfair practices in selection of the players by adopting illegal activities and unethical attitude for selecting players from other Districts to participate in the tournaments by neglecting the rights of the deserving players from District Sri Muktsar Sahib for consideration in the matches held by PCA.

AND

It is further prayed that independent inquiry be conducted with regard to the conflict of interest regarding the role of Members of the District Cricket Association as well as Coach and Umpire i.e. respondent Nos. 3 to 5 who in connivance with each other have bye-passed all the professional ethics and have adopted corrupt practices and favoritism towards the interest of their wards, siblings and for adopting the corrupt practices in selecting the players for consideration and for compelling the players to purchase the sports equipment from the

shop owned by them and are siphoning the huge commissions and margins.

AND/OR

It is still further prayed that till the regular inquiry is being conducted with regard to the role of the respondents, the charge of the District Cricket Association, Sri Muktsar Sahib be handed over to some independent person appointed by this Hon'ble Court for the smooth and fair governing of the District Cricket Association.

AND

Issue any other Order or Direction which Hon'ble Court may deem fit in the peculiar facts and circumstances of the case may also be passed in favour of the petitioners.

RESPECTFULLY SHOWETH:-

1. That the petitioners are residents of the abovesaid address and hence are entitled to file the present complaint against the illegal activities being carried out by the office bearers of District Cricket Association, Sri Muktsar Sahib.
2. That the Punjab Cricket Association (hereinafter referred to as PCA) is the governing body for the development and organization of the game of Cricket in the State of Punjab. The PCA is instrumental in running the coaching and other activities in all major Districts including District Sri Muktsar

Sahib. The object and purpose of PCA is to control and improve quality and standard of game of Cricket in the State of Punjab and Union Territory of Chandigarh, lay down policies, road maps, guidelines and make rules and regulations in all matters leading to game of Cricket, recognizing the primary stakeholders are the players and cricket fans in its area of operation and the accountability, transparency and purity integrity of game are the core values, to provide for measures necessary for promotions and development of the game of cricket, welfare and interest of cricketers and elimination of unethical and unfair practices in the game of cricket and to strive for sportsman ship and professionalism in the game of cricket and its governance and administration, inculcate principles of transparency and ethical standards in players, team officials, umpires and administrators and to ban age fraud and other forms of inequity and discrimination.

3. That the brief facts of the case are that the petitioner No. 1 is father of minor aspiring cricket player namely Armaan Partap Singh Sidhu who is a registered as a player in District Cricket Association, Sri Muktsar Sahib (hereinafter referred as DCA) and the son of petitioner No. 2 i.e. Lovedeep Singh is registered Under-19 District Player in the year 2025. The petitioners are forced to knock the doors of this Hon'ble Court due to the conflict of interest, unfair practices and unethical approach adopted by the respondents. As the respondents are forfeiting the rights of the genuine players and are playing with their future and sports career for their self-benefits and

consideration amount. The DCA has been made as a business house by respondent Nos. 2 to 5 and are making huge amount by adopting unfair practices by forcing players to buy the sports equipment from the shop of respondent No.5 which warrants the inquiry by this Hon'ble Court. The photograph of the GSM Sports Hub owned by respondent No.5 is annexed herewith as **Annexure P-1** and photograph of the GSM engraved on the cap along with logo of DCA is **Annexure P-2**. The respondent No. 5 is also selling sports apparels with the copied logo of PCA from his shop to earn huge margin. The copy of the same is **Annexure P-3**. It is further relevant to bring to your kind notice that respondent No. 5 is forcing the players to purchase all the sports equipment and apparel from his shop or to face dire consequences.

4. That the main motive of respondent Nos. 2 to 5 is to make money out of the DCA and are not all bothered with regard to the condition of the cricket grounds and pitches. Even no equipment or facilities are being provided to the players in DCA like balls, any fitness articles or any nets facilities. The cricket ground is in dilapidated condition and weed has grown around the net practice area. The photographs corroborating the same are **Annexure P-4**.

5. That since last few years, respondent Nos. 2, 3 and 5 i.e. Secretary Shaminder Batra, Member of DCA Maninder Chopra and Coach of DCA Muktsar Gursant Singh have made their nexus of promoting their own wards and

players and are making them as lead players in the cricket teams. Shaminder Batra and Maninder Chopra both are Government Teachers are having links with very influential persons and due to their influence they have adopted the unethical and illegal practices in the Association and does not adhere to the voices of the aggrieved persons. Due to their act and conduct of conflict of interest, deserving players are not being given the fair chance to participate in the tournaments and are being humiliated mentally and physically by the respondent Nos. 2, 3 and 5 as they are acting hand in glove with each other and the players of their choice are being provided with the coaching facilities as well as are allowed to participate in the matches. Whereas, the players without having the backing of the DCA are not being allowed to play as per their caliber and are humiliated to quit the cricket game unless they dance to the tunes of respondent Nos. 2 to 5.

6. That it is further pertinent to mention here that only those players are allowed to play in the PCA matches who are having the backing of respondent Nos. 2 to 5 and they have adopted the corrupt practices of taking bribe from the players who are allowed to play in the PCA matches. The kin and kith of the respondent Nos. 2 to 5 are given preferential treatment and the nepotism is prevailing in the DCA and the fair chance of the deserving players is being forfeited.

7. That the son of the petitioner No. 1 represented in under-16 in Inter District Tournament of PCA but his fair

chance to play was intentionally forfeited and he was only allowed to play in one or two games even after performing well in the selection and practices matches. The son of the petitioner No. 1 had been targeted and harassed by the respondent No. 5 as well as respondent Nos. 2 to 4 because they were eying consideration from the petitioner No. 1. However, petitioner No. 1 refused to act to their tunes. Due to the refusal of petitioner No. 1 for obliging the respondent Nos. 2 to 5, the son of the petitioner No. 1 has to pay the price even the son of the petitioner No. 1 had also raised the issue before the respondent Nos. 2 to 5 why he is being discriminated while he is performing well. Then the son of the petitioner also forced to purchase shoes from the shop owned by respondent No. 5. A receipt of the payment is **Annexure -P5**.

8. That the son of the petitioner No. 1 has been continuously targeted and is being victimized of the nepotism and favoritism prevailing in the DCA. The behavior of the respondent No. 5 towards the son of the petitioner No. 1 is very rude and harsh. The language used by the respondent No. 5 towards the son of the petitioner No. 1 is abusive and derogatory and due to his act and conduct, the son of the petitioner started remaining tense and under pressure. When the petitioner No. 1 inquired from his son why there is a change of behavior and why he is remaining so tense then he narrated the entire occurrence to the petitioner No. 1. Thereupon, petitioner No. 1 raised concern before the Association but to no

avail and had to face further humiliation at their hand. As respondent Nos. 2 to 5 created nexus for minting the money under the garb of the DCA.

9. That the petitioner No. 1 and his son have moved several complaints to the Deputy Commissioner, Sri Muktsar Sahib, District Sports Officer Sri Muktsar Sahib and District Education Officer, Sri Muktsar Sahib but to no avail and the attitude and conduct of the respondent Nos. 2 to 5 got further deteriorated towards the son of the petitioner No. 1 and they started openly proclaiming that this is our Association and nothing will happen against our will. "*Assi us nu khadawange, jo sade godde ghutuga. Tusi jithe marji bhaj ke veekh lavo sada kuch nahi vigaad sakde, sadi paunch buhot utte tak hai.*" The petitioner No.1 , his son and several other players also moved several complaints against the respondents which are annexed here with as **Annexure P- 6 to Annexure P-12.**

10. That in the November 2023, there were trials of under-14, the son of the petitioner No. 1 was intentionally not selected even though he performed out of class. Even the selectors had told that this child plays well and they shortlisted him. But Coach Gursant Singh i.e. respondent No. 5 refused to select the child of the petitioner No. 1 as he said you are not paying him on yearly basis nor purchasing equipment from his shop and you will face the music for moving complaints against us , therefore, he will not be selected and also abused him and further proclaimed to go home and not to return to the practice

area. The petitioner No. 1 raised the issue against the unfair selection, thereafter, since then the son of the petitioner has been made a scapegoat for teaching a lesson to the other parents if they will raise their voice against their illegal atrocities then they will also face the same music and purposely the son of the petitioner No. 1 was ignored in the selection process to satisfy the ego of the officials of the DCA. Their atrocities did not end here, they also refused to mark his presence when he used to go to District Cricket Academy whereas, the attendance of other players was being marked. The respondent No. 5 even removed the son of the petitioner No. 1 from the whatsapp group of DCA. A copy of the screen shot is annexed herewith as **Annexure P-13**.

11. That against the unethical act of the respondent No. 5, the petitioner No. 1 approached the respondent Nos. 2 and 3 to take action against the respondent No. 5 but they instead of looking into matter, used indecent words against the son of the petitioner No. 1 and further threatened him not to come back to the DCA or to face the dire consequences and further openly proclaimed that till we are in the District body we will not let you represent and play from District Sri Muktsar Sahib. Due to the said act of respondent Nos. 2 and 3, the son of the petitioner was under huge shock, fear and trauma. The son of the petitioner No. 1 started shivering while narrating the entire episode to the petitioner No. 1.

12. That thereafter, the petitioner No. 1 in order to save the future of his son ran from pillar to post and requested all the District Officers as well as the President of District Bar Association, Sri Muktsar Sahib and due to their intervention, the son of the petitioner was allowed to practice in the DCA. But the conduct and behavior of the respondent Nos. 2 to 5 was still the same but the petitioner No. 1 was hopeful that as they had agreed before the respectable persons that they will make the selection on the merits of the players. But in the under-16 Inter District Tournaments which was held in the year 2024, the son of the petitioner No. 1 was put on the standby in the 17 members list of players and he was ready to play when called upon. During the tournament, one batsman namely Jaskirat Singh was also harassed and he left the tournament in between, instead of calling a batsman to replace a batsman they called in a bowler and ignored the son of the petitioner No. 1 as he deserved a place in the squad. Now recently in April 2025, the son of the petitioner No. 1 got selected in Under-16 District Sri Muktsar Sahib team but he was not given a chance in first three games of the tournament. Even though, he deserved it being the fourth best batsman in practice matches. He was given a chance in fourth match, he scored 25 in the first inning, in the second inning, he was not allowed to bat one down but was forced to bat at 8th position even behind the bowlers, whereas, the son of the petitioner No. 1 is top order batsman. Even at the 8th position, the son of the petitioner No. 1 performed well and saved the match from the jaws of the

defeat. The score card of the first inning and the second inning are annexed here as **Annexure P-14 and P-15**. Thereafter, during the start of the next match on 16th April in the midnight 12 o'clock, a meeting was called by the Coach Gursant Singh in the hotel room and pressurized my child to sit in the particular position (Silly point) or you will not be allow to play but the son of the petitioner No. 1 insisted that he got injured and his shoulder is dislocated, doctor have advise him to take caution but Coach, Captain and Vice-Captain put the pressure, so that they can get and excuse and make the child sit out. The son of the petitioner No. 1 refused and he had written open letter to the Secretary and the other Association Officials on Social Media. A copy of the letter is already annexed.

13. That thereafter, when the petitioner No. 1 tried to raise the issue with regard to the treatment meted to the son of the petitioner No. 1 with the Association, their behavior was very rude and they bluntly refused and said this is not their problem you go and play for another District, here there is no place for your son. President of DCA Muktsar has asked for reply for the atrocities done by Coach Gursant Singh during the on-going tournament against the son of petitioner No. 1 but even after the lapse of more than five months, no reply till date has been filed by the respondent No. 5. The respondent Nos. 2 and 3 are protecting and safeguarding the respondent No. 5 for his unethical and inhuman treatment towards the son of the petitioner No. 1.

14. That the atrocities of the respondent Nos. 2 to 5 are not only faced by the son of the petitioner No. 1 but many other players are also undergoing the same harassment though very few gather the courage to raise the issue and the petitioner No. 2 submits that his son namely Lovedeep Singh was selected Under-19 District player in this year 2025 he was only allowed to play in one match out of the eight matches. He was also illegally thrown out of the team and was pressurized by Coach Gursant Singh so that he cannot get a chance to play even one day tournament. He was the top wicket taker in the practice matches played by Under-19 team, he was selected on the basis of his performance but in his place, Hanumansh Makkar son of Vinod Ashu Makkar was included, therefore, there is conflict of interest towards respondent No. 4 as he allowed his own son to play in the place of the son of the petitioner No. 2.

15. That the son of the petitioner No. 2 was the Captain of the Under-16 team. He bowled maximum overs and bats at his preferred position. Another player namely Robin Bawa son of a Coach from Jalalabad was also included in our team without giving any trial or playing any practice match. He was preferred over other players. Hanumansh Makkar alone bowled 25 overs and the remaining bowlers were collectively allowed to bowl 25 overs. The preferential treatment was given because his father is a PCA Umpire and a good friend of respondent Nos. 3 and 5. The son of the respondent No. 4 is Captain of Under-16 team as well as he also plays for U-19 team, which

clearly shows that the chance of other players is being ignored due to participation of the same player in both the teams depicting the direct conflict of interest and wrongly forfeiting the right of the deserving players in both the teams.

16. That in the same pattern, many senior players were also harassed on several occasions. But under the fear and terror of the respondent Nos. 2 to 5, they could not gather the courage to raise the issue against the illegal, unethical behavior and the act of conflict of interest of the respondent Nos. 2 to 5.

17. That the petitioners also wants to bring to your kind notice that the act and conduct of respondent Nos. 2 to 5 as mentioned below:-

- (a) A senior player namely Shubdeep was slapped and beaten by respondent No. 3, but no action was taken against him.
- (b) Another player namely Arpit, a leg spinner was beaten and his neck was strangulated by Coach Gursant Singh but no action was taken against him. In the end he was forced to leave the game permanently as he did not gather the courage to raise his voice.

18. That the behaviour of Gursant Singh Coach with the children is very rude and arrogant. He uses abusive language with the players and does body shaming to the players like saying you are "Gay" and ask personal questions

with regard to the private life of the parents of the players whether your parents have love marriage or arrange marriage. It has already been brought to your notice that Gursant Singh Coach DCA has opened his own cricket shop outside the cricket Academy and only those players who buy cricketing gears from him are given preference. Coach Gursant Singh also runs a private cricket academy in "Sant Gurmukh Singh School" in Muktsar where he gives coaching to the cricket players and charge them on a monthly basis and the players who play in his private academy are given preference over the others.

19. That many other players have also moved complaints against the PCA registered Umpire and members of the DCA but no action has been taken against them. The name of other players who also faced harassment are Morkel and senior players namely Hardesh, Reavenpreet, Uday Kakkar, Harman Kamboj, Dev Midda faced similar treatment at the hands of the Respondent Nos. 2 to 5 and also moved complaints , one such complaint moved by Morkel is annexed herewith as **Annexure P-16**.

20. That it has also further come to the notice of the petitioners that a DCA member Maninder Chopra i.e. respondent No. 3 also demanded Rs. 10,000/- from a player so that he can make him play in the district matches. With such type of nexus of bribery going on in DCA, the talented players have to suffer immensely and are also are not given chance to play in the matches thus playing havoc with their careers.

21. That the environment provided by the DCA is not conducive for the players as apart from the physical needs of the players like fitness training etc. , the mental well-being of the players is also equally important aspect in nurturing the overall development of a player which is completely ignored here in DCA and rather they are treated with abusive language, mental harassment and players are subject to mental torture, body shaming, personal comments on the family all the time including faulty and biased selection process due to conflict of interest of the Coach and Umpire in selecting their own kids and those who practice with them privately by paying hefty amount.

It is therefore respectfully prayed that strict and appropriate action may kindly be taken against the office bearers of the District Cricket Association, Sri Muktsar Sahib for conflict of interest, unfair practices, favoritism, prioritizing and biased approach towards their own wards, relatives and forfeiting the right of the deserving players and for de-affiliation of the District Cricket Association, Sri Muktsar Sahib.

It is also prayed that strict legal action be taken against the respondent No. 5 being the Coach of the District Cricket Association for harassing the minor players mentally as well as physically by abusing, beating them to such an extent that they are forced to quit the game due to his such unethical and inhuman treatment and for conflict of interest by selling the cricket equipment under his name and forcing the players to

purchase all the sports equipment from his shop GSM Sports Hub bearing logo "GSM" and for selling sports apparels with the GSM logo as well as copied logo of PCA and also providing private coaching to the players by charging hefty amount and selecting them over the regular players.

Subject- Mentally Harasment Of the Children's
Respected Sir,

It is to bring in to your knowledge that we are the students of Distt Sri Muktsar Sahib who Represents the district in cricket. We have been mentally harassed by the association and the coach Gursant Singh Marar. We have been playing For in the association for past 1-2 years, the attitude of the coach and the association is very rude towards the children's. Respected sir, i Armaan Partap Singh Sidhu, currently I am playing in under sixteen inter district cricket tournament, sir it is to bring in you knowledge that I was hurt by a ball while fielding in a practice match held at sotha on 26 th March. I consulted a doctor and by taking X-ray and after seeing the injury he advised me to be more careful and make sure that if in future a ball is hit with such power and if it hits me it might dislocate my shoulder and it might be very harmful to you. I am more prone to it if I am fielding in silly point position. moreover sir I have not practice for that as it is a critical position for which a specialist fielder who is equipped with proper cricketing gears and specific training. it is my humble request that kindly keep me away from that position, if the ball hits it again on my shoulder it is dangerous for myself and my career. so once again kindly co-operate with me in this regard.

As my coach and captain is putting pressure on me to field in that position and black mailing me that if I don't field in that position your are not playing in final 11. with due respect I am withdrawing my name from the squad as they are mentally harrassing me. I am just 15 years old boy and my coach is senior to me, i respect my elders so I cannot argue with him on this matter as I have repeatedly requested my coach several times. I am begging to you all kindly help me in this matter.

My coach threatened me i will not play you in the 11 as you have to sit in that position only, sir this is not the cricket i know, if anything happens to me wholly and wholly coach Gursant marar will be responsible for it.

Moreover the coach is making video of me thai I am requesting to him that sir I cannot field in that position. sir I haven't done any crime that how the hell they are behaving with me during the middle of the night around 12.15 am.

My only crime is that I love cricket and from the last 3 years I have been the target of the coach. In under 14 trails I was rejected for no reason as the players who got selected was the one who was bowled thrice in front of me but I was not. that was the first time. i improved myself got selected in under 16 team but by a thin margin I was at stand by on the 17 position in the list but was not given a chance when a batsman withdraw himself in between the tournament. This time I was selected in the team against his will but didn't play in the first 3 games. I was given a chance in the fourth match against fazilka I batted at 2 down and scored 25 but my 2 fours were not added to my score, I requested to my coach and captain but they refused to go with me hence 8 runs were not added to our team total just because Armaan hit those boundaries. then came our fielding, 1 four went through me I midfielded, but 4 to 6 boundaries went through other fielders as well. Then my coach told me to field in silly point position, I resisted but to no avail, coach told me that I is our compulsion to play you in the match as you will not get the game in the next match as well. They come to know that I am injured and I didn't want to stand there to field. but they put pressure on me. sir I have not practiced it ever. they are exposing me to injury that without any practice about fielding in that position. i was hit twice that day but I stayed there then came the 2nd innings I padded as 1 wicket was down. my coach came and told me that why have you padded up you are not going to bat today. he told me to pack my kit. i packed my bags. As the match was

going on,7 wickets felled,he told me to go in ,I went in the middle and for God sake I saved the match and drew the match from jaws of the defeat.Today just before the night of the game at around 11.30 pm a meeting is called by the coach, asked me that if you want to play tomorrow you will be fielding in the silly point position.sir after various requests and repeated attempts to tell them.i failed to convince him and the captain.sir with connivance of coach and so called Captain and vice captain I was forced to sit out and without my any fault of me.i was made scapegoat.they want me to stop playing cricket which I cannot.please save me from this petty politics.Thanking you

Letter given to the President of the District Cricket Association of the -33- Amreli (P)

Respected sir, It is to bring into your notice that my son Partap Singh Sidhu, 15 year old is a budding cricketer, he has played for District Sri Muktsar Sahib in U-16. As my child was harassed mentally during the tournament, he wrote an open letter to the association in the mid night and told his grievance to every body. Letter regarding that is attached herewith. As this letter was written by my child openly, the coach Gursant Singh and one member named Maninder Chopra, a government teacher now are harassing my child to the extent that they openly threaten my child that we will not let you play in district cricket coz you complain about us. Coach Gursant Singh also threaten child to buy cricket gears from his own Shop he opened near the ground. We wrote to the PCA in 2023 November in U-14 trail where he conducted trails in biased manner. From the last two years my child is being harassed by coach Gursant Singh mentally as his behaviour with the child is very biased and cruel. As from time to time we wrote the letters to the PCA, deputy commissioner, association but no action has been taken against the coach Gursant Singh. Today the coach Gursant Singh and member of the association Maninder Chopra has openly told us flatly that your child will not be able to play in our district, you go and play for another district. When we approached the secretary of the association Mr Shaminder Batra about this he also supported them and directly refused us any that you go and play for another district.
