Subject: - Application with the request

- to take appropriate legal action against players playing with multiple birth certificates by committing age fraud by following "Delayed Birth Registration procedure", and making mockery of Principles of Natural Justice by playing with their Original as well as their Fake DOBs.
- request for de-affiliation of District Cricket Association (DCA) Mansa& removal of Sh. Jagmohan Singh, from the post of Secretary DCA Mansa as well as Life Membership of PCA apex council just to prevent his unethical as well as illegal activities by which he is allowing defaulter players to play with their multiple birth certificates and wrong domicile certificates just for minor monetary interests
- and further request for taking strict action against DCA Mansa coaches who arehaving hand in glove in facilitating the preparation of fake birth & domicile documents and also against PCA Mohali executives who are responsible for not providing necessary record to the investigation team of PS City Mansa for such wrongdoings and approvals and thus defaming the game of Cricket in Punjab, resulting that most the players representing Punjab have either 'Delayed Birth Registration with Late Entry or belonging to other states.

Respected Sir,

I ,Aman Kumar S/o Jiwan Kumar (Aged 42 years) resident of Mansa Punjab, is a social worker & advocate by profession. I am father of an aspiring cricket player registered in District Cricket Association (DCA) Mansa. My aim of raising this issue is to provide clean Cricket to Punjab genuine players, whose careers are being ruined by overage players.

Preliminary Submissions

- 1. In Punjab State, Cricket is being organized by Punjab Cricket Association (PCA) SAS Nagar affiliated with BCCI, in 2019 PCA adopted new constitution, as per new constitution, main objective of PCA is to control the cricket in the area of Punjab through its affiliated District Cricket Associations and to control/ban age fraud in the game along with other objectives. It is the primary duty of the PCA and concerned DCA's to check and control age fraud.
- 2. In recent years most of the players have been registered with PCA through concerned DCA's having multiple Birth certificates by following "Delayed Birth Registration with Late Entry". They are not being registered with their genuine date of birth at District level, State Camps and Punjab State teams. All the players who are otherwise born after year 2000 and are already studying as regular student immediately registered their Date of births by following "Delay

Birth/ late entry procedures", made rectifications in Aadhaar cards, changed their schools with different Board of Education/ open school board without having previous school record. Thus involving educational institutions, District administration & District/ State Cricket Association in facilitating fake eligibility certificates of birth & domicile documents thus providing injustice to genuine players.

- 3. Until 2021, all the districts of Punjab State had been divided into Major and Minor districts. Prior to 2021, each major district (Patiala, Ludhiana, Jallandhar, Amritsar) was having their individual cricket team however a team had been formed from a cluster of the minor districts of Malwa region (Mansa, Sangrur, Barnala, Fazilka, Mukatsar, Ferozpur, Faridkot) and other team was formed from a cluster of minor districts of Majah&Doaba regions like (Gurdaspur, Batala, Tarantaran, Hoshiarpur, Nawanshahar).
- 4. In 2021, all these minor districts were also elevated to the same status as that of Major Districts like Jallandhar, Amritsar, Ludhiana & Patiala. ShRajinder Gupta President PCA Mohali provided them enough donations to maintain their proper grounds and even monthly emoluments were fixed for a fleet of coaches at each & every districtlevel.
- 5. Unfortunately all these District Cricket Associations only played the role of undergoing selection trials for the selection of all age group district teams instead of providing them proper coaching. Resultantly culture of private cricket academies mushrooming up.
- Aspiring players are taking coaching from Private cricket academies and concerned District Cricket Association coaches just organized trials for the selection of all age group district teams.
- 7. After taking trials, the learned secretary of each District Cricket Association initiated the process of registration of each selected player for every yearly session. The learned Secretary of concerned DCA is responsible to scrutinize all their documents and further he sends these documents online, in scanned PDF form, duly attested by the secretary DCA to PCA Mohali for final approval.
- 8. The eligibility criteria for the registration of the players is date of birth limits to accommodate them in respective age group teams and second is concerned district domicile. For concerned district domicile the player should have birth of concerned district or should have been resident of concerned district since last two years. To proof resident of concerned district, the player should have to proof either studying or doing job/ employed in the concerned district since last two years. In addition to that PCA Mohali had even allowed 3 guest players from other states or districts, provided they should have NOC from their parent District Cricket Association. Copy of BCCI/PCA rules regarding eligibility criteria is annexed herewith as **Annexure P1**.
- 9. Purpose of elevation of minor districts was to provide equal opportunity to all minor districts players with their respective major districts. Secondly guest players are allowed with a purpose that if at a district level, there are enough efficient players and could not be all accommodated in concerned district team then they could have option to move to other district to have proper exposure. But the concerned District Cricket Association executives/ coaches violated this

good purpose and started business of inducting other districts or other states overage players for their monetary interests. District Cricket Association (DCA) Mansa had crossed all limits and every year constituting District Mansa Cricket team of players inducted from other districts & states specifically from Rajasthan, UP, Delhi & Haryana State.

- 10. Coincidentally Sri Ganganagar District had litigation with Rajasthan Cricket Association, So
- a. One Sanjeev Saharan Cricket coach of Sri Ganganagar got registered his son Udhay Saharan in Bathinda district cricket association in 2016.
- b. Sanjeev Saharan is also running a cricket academy in Sri Ganganagar.
- c. Sanjeev Saharan registered birth of Udhay Saharan by following 'Delay birth registration procedure' prior to getting registration in Bathinda Cricket Association.
- d. After getting Delay birth registration birth certificate he got admission in Kids Camp Convent School, in Sri Ganganagar being run by one Sh. Arvind Godara. Arvind Godara also father of a cricket player KeshavGodara who also got his registration in Bathinda Cricket Association.
- e. Both Udhay Saharan, KeshavGodara got Demi admissions in local Bathinda district.
- f. By following such modus operandi a large number of players got admissions in different minor districts and specifically District Mansa.
- 11. Such other states/ districts players are otherwise failed to be selected in their respective district/state trial selections & are not enough efficient to represent their own respective districts or states but are being provided opportunities in these minor districts for monetary interests of concerned minor DCA executives. Specifically DCA Mansa showed more monetary interests in other districts/states players (specifically of Rajasthan & Haryana State) and thus started ignoring the registration of local resident players.
- 12. Shockingly most of these players are submitting their birth certificates registered by following 'Delay Birth Registration procedure, Late Entry' instead of regular birth registration. But all these players had same modus operandi:—
- a. All these players got registered their birth at the age of 12-13 to 15-16 years old, mostly prior to their middle examination and even after appearing in middle or Secondary examinations or we can say at the time they started Cricket game.
- b. All these players then succeeded in getting admissions in schools with such fake birth certificates without providing previous school records. Resultantly some are studying as regular student parallel in both states. Aditya Balana is main example of such case. Copy of report card of 8th class appeared in Sacred Heart Convent School, Rajasthan State of 2019-20 sessions is annexed herewith as **Annexure P-2**. Copy of progress report of 8th class appeared in 2021-22 in Alpine Valley Public School, Aklia (Mansa) is annexed herewith as **Annexure P-3**.
- c. There is a Maha Rishi Markanda Educational & Vocational Training Society vir Nagar Mansa. If these defaulter players could not get admission in regular school then they got admission in this Centre. DCA Mansa & even PCA Mohali

accepted certificate of this computer Centre for District Mansa domicile eligibility criteria.

- d. Then they updated fake date of birth and fake Mansa addresses on Aadhaar cards & even prepared voter cards.
- 13. Otherwise all the present active players may have born since 2000. Since 2000, every child must have born either in government or private Nursing homes. It is mandatory for every hospital to register the birth with concerned district civil surgeon office. Now every hospital, civil surgeon office is maintaining digital birth record in every district/ state since 2000.
- 14. Even then some District administrations are registering birth of regular school going students who had already some date of birth &Aadhaar Card records in their respective schools and had even completed their middle/secondary education examinations. Suddenly their parents declared another date of birth which is always one year to six-seven years younger than their previous given date of birth and at last they registered their new date of birth by following 'Delay birth registration procedure. Basically 'Delay Birth registration procedure' is only for such old persons who were otherwise illiterate or belonging to remote areas and due to rational reasons they could not registered their birth in their early ages. But now birth registration is mandatory for getting initial admission in the schools and e-portals are being maintained by respective district education offices.
- 15. After change of date of birth they also changed the educational board and got admission in some school of different education board without submitting their previous school record. So if he/she was studying in school under CBSE then after changing DOB, he got the admission in the school running under Punjab School education board or under open school board.
- 16. Instead of maintaining e-portal school admission system, these minor districts Cricket Associations specifically District Cricket Association Mansa had succeeded in facilitating admissions of these overage players in regular government & private schools.
- 17. District Mansa Cricket Association Coaches and Secretary Jagmohan Singh in addition to registering such other states/ districts overage players also started instigating local Mansa district players to follow same delay birth registration for local Mansa players also. Details of such Mansa District residents players described in tabular form is annexed herewith as Annexure P-4. DCA Mansa modus operandi is as follows:—
- a. DCA Mansa initially registered the eligible local resident players with Mansa Cricket Association with their original date of birth. Later the officials/coaches guided the players to minimize their age.
- b. Then with the instruction of the above Coaches, the parents of these players are guided to minimize their ages 2 to 4 to 6-7 years by following 'Delay Birth registration procedure'. The players, who are otherwise regular students of government & private schools and even had done their middle or secondary examinations under CBSE or Punjab, Rajasthan or Haryana State Boards succeeded in registering fake date of birth of these players by following 'Delay Birth Registration procedure.'

- c. It is learnt that for applying delay birth registration, they first tempered DOB on the Aadhaar card and then they showed admission in local Mansa schools or in most cases admission in Maha Rishi Markanda Educational & Vocational Training Society shown as registered under Govt. of India Act XXI of 1860. After showing these two types of documents then these defaulters apply for delay birth registration.
- d. Maha Rishi Markanda Educational & Vocational Training Society is such a fake Centre that it neither needs any roll call presence nor had been audited by any supervisory authority but surprisingly PCA & Mansa District administration accepting it's certificate for district Mansa Domicile eligibility criteria.
- e. With the change of date of birth (DOB) they also changed the board of education or appeared in Secondary education examinations in open school boards as private candidate.
- f. After getting fake birth certificates then they got updated date of birth on their respective Aadhaar& Voter cards.
- g. To have Punjab/ Mansa District domicile, other state resident players are even updated their Aadhaar cards with fake Mansa District addresses.DCA Mansa Secretary/ Coaches even provided their own addresses or facilitated addresses of co-players.
- h. Surprisingly both DCA Mansa and PCA Mohali although very well know about the overage of the players by even their physical appearance and even having records of their original date of birth but even then they approved these defaulter players to play with their new fake date of birth.
- i. These defaulter players were being facilitated by Secretary and Coaches of DCA Mansa to get admission with their fake birth certificate in the local Mansa schools. They have modus operandi that after changing date of birth they also changed the education board or appeared in Matriculation Examination as an open board student.
- 18. Basically these wrongdoings should be prohibited by the coaches. But there are precedents when coaches themselves had minimise the age of their own wards:—
- a. Aryan Yadav son of ShDileep Yadav, a cricket coach running his own academy Bilievers Cricket Academy Patiala was having his original DOB as 15/4/2007 in Durrani Hospital Varanasi Uttar Pradesh(at 01:05 am which was registered on 23/4/2007. Copy of Registrar Birth & Death register is annexed herewith as Annexure P-5 and its true translation as Annexure P-5/T. But his father Dileep Yadav had again registered his fake birth by following 'Delay birth registration procedure' on 15/11/2008 that his son Aryan Yadav's fake date of birth is 15/4/2008. Copy of original birth certificate and fake birth certificate is annexed herewith as Annexure P-6 and P-7 respectively. That means cricket coach had planned to minimise the age of his son just after a period of one year after his son's birth. If this is the situation then who will rectify the system. Same procedure he may have adopted for her daughter Shruti Yadav player of PCA also.
- b. One more example is Udhay Saharan s/o Sanjeev Saharan a Ganganagar, Rajasthan based Cricket Coach who had registered the birth of his son Udhay

Saharan in 2016 by following 'Delay birth registration procedure' just prior to his registration in Bathinda District Cricket Association. Copy of birth certificate of Udhay Saharan is annexed herewith as Annexure P-8. Although he had got admission in Govt. Senior Secondary School boys Bathinda for Punjab domicile eligibility but for Secondary/ Matriculation Examination he had appeared in open CBSE board as a Private candidate. Otherwise as per BCCI rules, players having delay birth registration is eligible for U-19 age group for only limited 2 years. Copy of BCCI Rules is annexed herewith as Annexure P-9.But Surprisingly UdayPratap Saharan is playing at State, National as well as international level for continuously fourth year that too as Captain of Punjab State Cricket team.

- 19. There is one more example of Harish Kumar s/o Isher Ram r/o Rajasthan, presently living at BilaspurMoga and shown place of birth as village Nazamwala Ferozepur and had registered himself with minor District Cricket Association, Moga.
- a. Harish had studied in Guru Nanak Public School, Bilaspur, Mogaupto 8th class with DOB as 5/10/2005.
- b. In 2018-19, Harish had appeared in eighth Class examination from PSEB through Govt. Multipurpose Senior Secondary School, Patiala vide Roll no.8255551 with date of birth 5/10/2005.
- c. then he started playing cricket
- d. On 20/2/2020 again his parents deposed before administration and declared date of birth as 05/10/2007 and got Birth Certificate vide registration No. DPH/368 dt 20/2/2020 by following 'Delay Birth Registration Procedure' in Sub Registrar office MamdotFerojpur.
- e. After changing date of birth as 05/10/2007, Harish had switched to CBSE and started studying in 12th B Class in Kaler International Senior Secondary School, Smadbhai, Moga.
- f. Let us overlook the case of Harish Kumar. Harish kumar had appeared in middle standard examination in 2018-19 so he must be in first class in 2010-11. If Harish had born on 05/10/2007 then in three years after birth he got admission in first class. Although all his classmates also having same birth year of 2005 which is genuine as per his previous given date of birth. Copy of admission register of Guru Nanak Public School BilaspurMoga is annexed herewith as **Annexure P-10**. According to the school admission register all his classmates are having 2005 as his birth year except one as Feb 2006.
- g. Many parents approached PCA Mohali against Harish kumar with school record of both his DOBs and logically tried their best to convince PCA authorities that his DOB is 05/10/2005 but instead of giving rational reasons about accepting his rectification of DOB as 5/10/2007, PCA authorities just adamant to stick upon birth certificate generated on wrong facts.
- h. Now this Harish Kumar had got illegitimately rectified his Aadhaar card, PAN Card mentioning DOB as 05/10/2007.
- i. Otherwise Harish Kumar basically belongs to Rajasthan state, living in Village Bilaspur District Moga, showing birth place as village Nizamwala, Ferozpur and it is very difficult for parents of co-players to find out his original

birth date & place until concerned District Cricket Association is not ready to find out the factual position.

- 20. There is a political angle also. All these minor districts Cricket association's Secretaries were also appointed as life members of Punjab Cricket Association and got voting power in the selection of Office Bearers of PCA.
- 21. Resultantly all these minor districts become more powerful by getting voting power. Instead of improving Cricket Game Culture in the minor districts they started mushrooming up irregularities in the selection process of these districts. Resultantly they did not provide coaching to the local players but they registered other states & districts players either as guest players or illegitimately created documents for district Mansa domicile criteria. DCA officials and coaches even facilitated in the preparation of their Aadhaar& Voter Cards at own addresses and the fake addresses
- 22. Most of these minor districts are border districts of Rajasthan & Haryana State. In Haryana, Sirsa Shah Satnam Ji Cricket Academy having Jaskaran Singh Coach became source of players. Similarly Sri Ganganagar Cricket Association has long lasting litigation with Rajasthan Cricket Association. So Sanjeev Saharan Cricket Coach of SriGanganagar district started providing players for these adjacent minor District Cricket Association teams like Mansa, Bathinda, Fazilka&Barnala. Even Sanjeev Saharan Coach resident of Sri Ganganagar became coach of Fazilka district also for some time.
- 23. Unfortunately all the above developments being misused by these minor districts executives. All these minor districts specifically Mansa District Cricket Association started registering overage other states & districts resident players without giving opportunity to local Mansa district players. If 2-3 local Mansa district players are selected in 15 member's team, even then these local district players could not be given playing in all the matches of the tournament. Resultantly except sons of Jagmohan Singh secretary DCA Mansa & some defaulter overage players, no other genuine Mansa district player could get selection in the state camps.
- 24. Surprisingly only those local Mansa district resident players had been selected in the State Camp who could illegitimately minimize their age ranges from 2-4-6 years. Detail of such local Mansa District players is annexed as **Annexure P-11**.
- 25. Because of having Senior Akali Dal legend stalwart of DCA Mansa, most of the local government or private schools under pressure gave admission to these defaulter players with the recommendations of DCA Mansa Secretary or coaches. Surprisingly they were being provided admission in the schools without getting previous school record in the form of 'School leaving Certificate'
- 26. Most of the Rajasthani overage players got admissions without submitting 'School leaving Certificate' of their previous school in the local Mansa schools just with the recommendations of Secretary & Coaches of DCA Mansa that is why the player like Aditya Balana could study as regular student parallel in both Rajasthan & Punjab State Schools and are representing DCA Mansa as local residents.

- 27. Similarly overage local Mansa district players being local resident by birth and by getting admission in local Mansa schools become eligible to be registered with DCA Mansa. Surprisingly most of the birth registration by following 'Delay Birth registration procedure' are executed at SDM office Mansa. The details of such suspected defaulter players are described herewith in the tabular form which is annexed herewith as Annexure-P-12.
- 28. Details of one of the defaulter other state resident overage player, Randeep Singh s/o Bhupender Singh r/o AmarpurRathian, PilibanganHanumangarh Rajasthan is as follows:-
- Randeep is having original DOB as 01/04/2001. (Copy of original birth certificate is annexed herewith as Annexure P-13 and it's true translation as P-13/T)
- b. Randeep did his Senior Secondary education upto 2016 under CBSE from Genius Little Flower Public School, Pilibangan Rajasthan. (Copy of admission register of Genius Little Flower Public school Hanumangarh and Copy of Secondary Examinations Certificate under CBSE are annexed herewith as Annexure P-14 & P-15 respectively).
- c. During this time he also got registered with Rajasthan Cricket Association with his original DOB.
- d. Then in 2018 Randeep& his parents falsely deposed before the administration and again got registered his birth as 01/11/2003 by following 'Delay Birth Registration Procedure.'(Copy of delay birth certificate is annexed herewith as **Annexure-P-16**).
- e. Surprisingly in 2019 above Randeep again did his Secondary examination under Board of Secondary Education, Rajasthan through a Demi school GD Model Secondary School, Ward No. 2 Sureshia, Hanumangarh. (Copy of Secondary Education Certificate is annexed herewith as **Annexure-P-17**).
- f. After changing his date of birth he got again got admission in Genius Public Senior Secondary School Pilibangan under Secondary Education Board Rajasthan. (Copy of NOC issued by Genius Public Senior Secondary School Pilibangan is annexed herewith as **Annexure P-18**).
- g. Basically both schools, Genius Little Flower Public School under CBSE & Genius Public Senior Secondary School PilibanganHanumangarh under board of Secondary education Rajasthan are being run in the same premises by same owner.
- h. After changing date of birth & got admission in same type of school premises under different educational boards of education
- i. Randeep again registered himself with Rajasthan Cricket Association vide RCA Registration No. RCA-000-833 with his fake date of birth on 04/04/2021.
- j. Rajasthan Cricket Association issued show cause notice to Randeep regarding discrepancies in his dates of birth (Copy of Show Cause Notice is annexed herewith as **Annexure P-19** and it's true translation as **P-19/T**).
- k. Then instead of giving reply to Rajasthan Cricket Association he got registered himself with District Cricket Association Mansa and start playing U-19 inter-district matches being organized under PCA Mohali.

- Randeep on wrong facts and without getting 'school leaving certificate' from his previous school, got admission in Summer Field Senior Secondary School Mansa
- m. Randeep got voter card Vide EPICTURE No. SWA3117165 at the fake address 713-M, Ward No.6, Near Peer Khanna Mansa. A Copy of Voter Card is annexed herewith as **Annexure P-20**. Although his whole family is living at his native place at Hanumangarh Rajasthan.
- n. Randeep also got Aadhaar Card No. 755562808623 having fake date of birth as 01/11/2003 and fake address as Peer Khanna Ward No. 6, near Court Road, Mansa. Copy of Aadhaar Card is annexed herewith as **Annexure P-21**
- o. Surprisingly Rajasthan Cricket Association vide reference No. RCA/ CRIC/ 2021-22/1045 dated 31/03/2022 issued NOC to Randeep to participate from Punjab Cricket Association from the season 2022-23. Copy of NOC is annexed herewith as Annexure P-22 and it's true translation as Annexure P-22/T.
- p. Randeep then played in the team of Punjab Cricket Association and participated
- i.While representing DCA Mansa, he had participated in various inter-district tournaments in 2021-22 and played in U-19 one day, U-19 days, U-23/25 and Senior one day and Senior T-20.
- ii.In 2022-23 while representing DCA Mansa, Randeep had played U-19 one day, U-19 days, U-23/25, Senior Days, senior one day and Senior T-20.
- iii.At National level tournaments (Vinod Markan& Cooch Behar tournaments 2022-23) where he had been again objected due to his overage.
 - q. It revealed that
- i.Randeep had legitimately studied under CBSE board then after changing date of birth he had studied under Board of Secondary Education Rajasthan. Otherwise every student must have been provided with a registration number/ id and so DOB could not be changed.
- 29. Details of other defaulter overage player Saksham Mittal s/o Ramesh Kumar r/o Vaid Kapoor Street Ward No. 15, Jawaharka Road, Mansa is as follows:—
- a. Saksham Mittal having original Date of birth as 4/4/1997 and place of birth as Rajan Nursing Home Patiala. Copy of birth certificate is annexed herewith as Annexure P-23 and it's true translation as Annexure P-23/T.
- b. Saksham Mittal did Secondary School Examination in 2011-13 vide Roll No. 2220897 & got admission in Senior Secondary School in 2013-14 through SDKL DAV Centenary Senior Secondary School Mansa
- c. Saksham Mittal from April 2014 to 09/07/2015 through Manu Vatika School

- d. Saksham Mittal in 2015-16 did 10+2 Commerce through S.Chetan Singh Sarvhitkari Senior Secondary VidhyaMandir.
- e. Saksham Mittal vide Roll No. 16046481 got admission in BA Part-1 in 2016-17 from DAV College Chandigarh. Copy of DAV College Chandigarh is annexed herewith as **Annexure P-24**.

- f. Saksham Mittal had registered himself with District Cricket Association Mansa and had played cricket while representing DCA Mansa with his original Date of birth as 4/4/1997.
- g. On 10/11/2021 vide registration No.BU/ES/21/00026449661 dated 10/11/2021 Saksham Mittal & his parents deposed wrong facts before the administration and he got fake birth certificate mentioning DOB as 4/9/2003 from SDM office Mansa. Copy of fake birth certificate is annexed herewith as Annexure P-25.
- h. Sakshamkumar got Aadhaar Card No.278745628790 mentioning fake date of birth as 04/09/2003.
- i. In October 2020 (open) Saksham Mittal got Matriculation Examination certificate under PSEB vide Roll No. 1020831166 through Dashmesh Public Senior Secondary School Court Road Mansa. Copy of October 2020 Matriculation Examination Certificate is annexed herewith as Annexure P-26. Surprisingly by that time Saksham Mittal was not having fake birth certificate as 4/9/2003. So Saksham Mittal as Saksham Kumar got admission in Dashmesh Public Senior Secondary School Court Road Mansa without having birth certificate or previous school leaving certificate.
- j. Saksham Kumar vide admission No. 10644 studied & passed in 10+1 Section C, Humanities group vide Roll No. 332 in 2020-21,(Copy of 10+1 Humanities group is annexed herewith as **Annexure P-27**. Saksham Kumar did 10+2 (Arts group) in 2021-22 from S.D.S.E. Senior Secondary School Patiala.
- k. In 2021-22, Saksham Kumar had participated in inter-district tournaments U-23/25 & Senior T-20 tournaments.
- I. Saksham Kumar had been selected in State Camp of U-23/25 group being held at PCA Mohali under the supervision of Sh Sunil Saggi Coach. Surprisingly PCA Mohali authorities shifted Saksham Kumar from U-23/25 State Camp to U-19 State Camp. By that time even Saksham Kumar was not having his fake birth certificate mentioning DOB as 4/9/2003.
- m. In 2021-22, Saksham Kumar participated in Cooch Behar Tournament. By that time Saksham Kumar was not having his fake birth certificate mentioning DOB as 4/9/2003. Jagmohan Singh Secretary DCA Mansa just forwarded a handwritten application of Ramesh Kumar father of Saksham Kumar to PCA Mohali and further to BCCI. Copy of handwritten application is annexed herewith as Annexure P-28& it's true translation as Annexure P-28/T. DCA Mansa & PCA Mohali certainly should be asked that at that time what type of documents must had been submitted by Saksham Kumar at the time of registration prior to inter- district tournament. As fake birth certificate mentioning DOB as 4/9/2003 had been registered or issued later on then what type of documents had been submitted by Saksham at the time of his registration. Certainly up to that time he had played with his original DOB as 4/4/1997 inen how DCA Mansa, PCA Mohali accepted his change of date of birth as 4/9/2003.
- n. Saksham Kumar had been selected for NCA Camp held at Wayanad Kerala commencing from 9/5/2022 to 20/6/2022.
- o. In 2022-23, Saksham Kumar had participated in inter district tournaments only in U-23/25.

- p. Later on his both dates of birth were come in the knowledge of PCA Mohali & so far no action had been taken by PCA Mohali or BCCI.
- There is also one of the social media input. In Facebook timeline post dated 18/11/2017, Jagmohan Singh Secretary himself displayed the Picture including the picture of above Saksham Mittal representing District Cricket Association Mansa U-23 (2017-18) Cricket Team Member as 18/11/2017.Copy of Facebook post on the timeline of accused Jagmohan Singh is annexed herewith as Annexure P-29. It is clearly mentioned that under the supervision of Secretary Jagmohan Singh and Coach Hardeep Sharma U-23 inter district Match between Mansa vs Faridkot was organized. Because a player could participate in inter-district tournament being organized by PCA Mohali only after registration of the concerned player in that session that too under sole attestation of Secretary DCA Mansa only. Certainly It is clear that Jagmohan Singh Secretary very well knows about the original DOB 4/4/1997 of Saksham Mittal. Certainly District Cricket Association Mansa and even Punjab Cricket Association must have the record of session 2017-18 as such record is mandatory to be maintained. Surprisingly only in District Mansa, most of the players are being played who had registered their birth certificate with delay registration process.DCA Mansa had ruined the future of so many players by instigating/directing/ supporting/ guiding most of them to minimize their ages.PCA should scrutinized details of forged state player Saksham Kumar @ Saksham Mittal s/o Ramesh Kumar registered since 2014 to 2022 in various age groups and different formats at district or state level.
- r. It revealed that Saksham Kumar had legitimately studied under CBSE board then after changing date of birth he had studied under PSEB. Otherwise every student must have been provided with a registration number/ id since his first primary class and so DOB could not be changed.
- 30. Details of other defaulter overage player, Jaspreet Singh @ Jassi @ Jasprit Singh s/o Gulab Singh r/o Chakerian Road Mansa is as follows:—
- Jaspreet Singh is having original DOB as 18/12/1999. Copy of original Birth certificate is annexed herewith as Annexure P-30 and it's true translation as P-30/T.
- b. Jaspreet Singh got admission in primary classes in Shivalik Public school Mansa with his original birth certificate
- c. Since 1/4/2014 to 31/3/2015. Jaspreet Singh got admission in Summer Field Secondary School and did 9th class in session 2014-15.
- d. Jaspreet Singh got admission in Matriculation Class (2015-16) in S.Chetan Singh Sarvhitkari Senior Secondary VidhyaMandirJawaharka Road, Mansa.
- e. On 04/11/2019 Jaspreet Singh & his parents wrongly deposed before administration his date of birth as 18/12/2005 and changed his name as Jasprit Singh and got issued his fake birth certificate. Copy of fake birth certificate is annexed herewith as **Annexure P/31**.
- f. Jaspreet Singh @ Jasprit Singh had got mentioned his fake date of birth as 18/12/2005 on his Aadhaar card Number 215947577280.
- g. Jaspreet Singh @ Jasprit Singh succeeded in doing his Matriculation Examination in October 2020 (open) through Professor Yogesh Memorial High

School Mansa vide Roll No 102083633017 mentioning his fake date of birth as 18/12/2005.

- h. In 2021-22, Jasprit Singh had played inter-district U-23/25, Senior One day & Senior T-20 tournaments with his fake DOB as 18/12/2005
- i. In 2022-23, Jasprit Singh had participated in inter-district tournaments U-19 one day, U-19 days, U-23/25, Senior One day & Senior T-20 with his fake DOB as 18/12/2005.
- j. There is a social media input. Secretary DCA Mansa Jagmohan Singh himself had posted a Picture of DCA Mansa U-16 team including Picture of above Jaspreet Singh on his timeline on Facebook on 02/12/2016. Copy of Facebook post on the timeline of accused Jagmohan Singh is annexed herewith as Annexure P-32. Basically Picture is of winner DCA Mansa U-16 team who had won against District Bathinda team. So on 02/12/2016, as per original DOB of above Jaspreet, his age was about 16 years old. But on 02/12/2016, as per fake DOB 2005 of Jasprit Singh his age was just 11 years old. As Jaspreet had prepared/registered his fake birth certificate on 04/11/2019. So on 02/12/2016 Jaspreet must have played with his original DOB. So Jagmohan secretary and coach had allowed Jaspreet to play with his original DOB in 2016 as well as with fake DOB in these days. PCA must securitize especially details of DCA Mansa Player Jaspreet Singh @ Jassi registered with PCA in any session, in any format since (2014 to 2022) while representing District Cricket Association Mansa.
- k. It revealed that Jaspreet @ Jasprit Singh had legitimately studied under CBSE board then after changing date of birth he had studied under open PSEB Board. Otherwise every student must had been provided with a registration number/ id since his first primary class and so DOB could not be changed.
- 31. Detail of other overage defaulter player, ShubhamSingla s/o Darshan Kumar r/o Shiv Colony VPO Cheema tehSunam Sangrur is as follows:—
- a. ShubhamSingla is having original date of birth as 09/06/2002. Copy of original birth certificate is annexed herewith as **Annexure P-33**.
- b. On 12/7/2005, ShubhamSingla had got admission in Akal Academy Cheema vide admission No. 1731 in Nursery class and remain in the school till 26/3/2015 in 8th class.Copy of register of Akal academy Cheema is annexed herewith as **Annexure P-34**.
- c. On 24/3/2015, vide admission No. 7262 ShubhamSingla got admission in 8th Class in SDKL DAV Centenary Senior Secondary Public School Mansa. Copy of SDKL DAV Centenary Senior Secondary Public School Mansa is annexed herewith as **Annexure P-35**.
- d. On 20/7/2016, ShubhamSingla's parents got issued fake birth certificate with fake date of birth as 24/11/2004 by deposing wrong facts before the administration. Copy of fake birth certificate is annexed herewith as **Annexure P-36**.
- e. After getting fake birth certificate, ShubhamSingla then changed date of birth 24/11/2004 on his Aadhaar Card No. 979774728734. Copy of Aadhaar card mentioning fake DOB is annexed herewith as **Annexure P-37**.

- f. After getting fake birth certificate, ShubhamSingla got admission in BHS Senior Secondary School BarnalaKhara, Mansa vide admission No. 1701 and on 10/9/2019 he got school leaving certificate for 9th class.
- g. ShubhamSingla vide Roll No. 1020415622 did matriculation Examination in March 2020 from Shakti Public Senior Secondary School, Doraha, Ludhiana. Copy of detail Marks sheet is annexed herewith as **Annexure P-38**.
- h. ShubhamSingla did BA Part-1 during Session 2022-23, vide roll No. 348 in National College Bhikhi Mansa. Copy of Bonafide Certificate of National College Bhikhi Mansa is annexed herewith as **Annexure P-39**.
- i. There is a social media input, by which the Secretary Jagmohan Singh had posted a Picture of DCA Mansa U-16 imam including Picture of above ShubhamSingla on his timeline on Facebook on 14/11/2015. Copy of Facebook post on the timeline of accused Jagmohan Singh is annexed herewith as Annexure P-40. Basically Picture is of winner DCA Mansa U-16 team who had won against District Bathinda team. So on 14/11/2015, as per original DOB of ShubhamSingla his age was of 13 years old. But as per his fake DOB 2004 of ShubhamSingla, his age was just 11 years old. As fake Birth Certificate registered/ issued on 20/7/2016 So on 14/11/2015, ShubhamSingla had played only with his original DOB 09/06/2002. So Secretary Jagmohan had allowed him to play with his both original as well as fake DOB. PCA must securitize especially details of DCA Mansa Player ShubhamSingla registered with PCA in any session in any format since 2014 to 2022 while representing District Cricket Association Mansa.
- j. It revealed that ShubhamSingla had legitimately studied under CBSE board then after changing date of birth he had studied under PSEB. Otherwise every student must had been provided with a registration number/ id since his primary first class and so DOB could not be changed.
- 32. Detail of Hitesh s/o Lal Chand r/o H.No. 4, street No. 14, Setia Colony, Sriganganagar falsely shown as resident of Chahal street, Street No. 08, Ward No. 6, Mansa is as follows:—
- a. Hitesh above having DOB 25/5/1997 had registered his delay birth registration on 16/04/2014.
- b. He updated his Aadhaar Card (692380691137) mentioning the fake birth registration 25/5/1997.
- c. Hitesh had completed his bachelor Physical Education in October 2020.
- d. So he had changed his date of birth in 2014 when he was doing his middle standard or may had registered himself with Rajasthan Cricket Association.
- e. Concerned DCAs or State Cricket Associations did not bother to check their previous school record of primary classes and doing atrocities with their coplayers.
- f. I couldn't understand that whether Punjab State or DCA Mansa has no bowler or batsman that they have to migrate him from Rajasthan.
- 33. Detail of Kuldeep Singh s/o Gurmeet Singh r/o water box, Jhunir, Mansa is as follows:—
- So far his original birth certificate couldn't be found out.

- b. He got registered his birth certificate on 10/1/2022 mentioning DOB as 05/10/2003 by following 'Delay birth registration procedure' and by deposing wrong information by his parents. Otherwise prior to this birth registration he was already a regular student of a school and certainly he must had already taken admission by declaring his original date of birth. Moreover since first primary class a student id must had been issued at district or state level and same at the e-portal also.
- c. After getting fake birth certificate Kuldeep Singh had done his matriculation examination under open PSEB in October 2020 through Govt Senior Secondary School Bajewala, Mansa
- d. He had done his matriculation Examination through open PSEB because while giving exams under open board previous school record is not required.
- e. On 12/12/2019, Jagmohan Secretary himself had displayed on his Facebook timeline, that in the inter-district tournament 2019-20, DCA Mansa U-19 Cricket team had won against District Sangrur team and hence qualified for final tournament. Jagmohan Secretary himself had displayed DCA Mansa U-19 team Picture, including Picture of one KuickepSingh.It means Kuldeep had played as DCA Mansa U-19 Cricket team member in 2019 under the supervision of Jagmohan Singh Secretary himself. It means in 2019 Jagmohan Secretary and coaches had allowed Kuldeep with his original DOB and now after instigating / facilitating him to prepare new birth certificate after minimizing his age, he again allowed him to play in 2021-22 session.
- 34. Details of one more suspected Rajasthani player Aditya Balana having original DOB as 10/3/2006 surprisingly studying as regular student parallel in both Rajasthan & Punjab State are as follows:—
- a. In 2018-19 he was studying in Sacred Heart Convent School Sri Ganganagar vide admission No. 7126 in 7th C Class vide Roll No. 20. Copy of Report Card is annexed herewith as **Annexure P-41**.
- b. In 2019-20, he was studying as regular student in Sacred Heart Convent School SriGanganagar vide admission No. 7126 in 8th B vide roll No. 21. Copy of Report Card is annexed herewith as **Annexure P-42**.
- c. In 2020-21, he was studying as regular student in Sacred Heart Convent School SriGanganagar vide admission No. 7126 in 9th B vide roll No. 28. Copy of Report Card is annexed herewith as Annexure P-43.
- d. In 2021-22, he was regular student in Alpine Valley Public School, Aklia Mansa vide admission No. 1110 and surprisingly again got admission in 8th class. Copy of progress report 2021-22 is annexed herewith as **Annexure P-44**.
- e. Aditya Balana had played U-16 cricket team representing SriGanganagar Cricket Association in 2021 December and without getting NOC from SriGanganagar Cricket Association he had been allowed to represent DCA Mansa U16 team & U-19 team.
- 35. All the above described averments clearly showed that Punjab Cricket Association as a whole and District Cricket Associations of minor districts specifically District Mansa stakeholders/ executives/ Coaches/selectors encouraged the scam by allowing playing of overage players instead of booming up real sportsmanship. Coaches are not ready to provide proper hard work for

coaching to their players but always trying to instigate their players to minimize their ages by following 'Delay Birth registration procedure' which had enough flaws in the system.

- 36. Although Delay/late Birth Registration Procedure' is a long procedure which is basically for old, illiterate persons who may have forget to register their birth to the concerned District Registrar (Birth & Death) office or related with the time when Dhayi (domestic lady/ mother who helps at the time of birth) forget to inform District Registrar office (Birth & Death). To apply late birth registration an applicant had to submit
- a. Affidavit / Self Declaration of Father and Mother
- b. Affidavit / Self Declaration of Materinal Family Nana and Nani Or Mama and Maami
- Affidavit/ Self Declaration of two MC's / Sarpanch.
- d. Certificate from Dai.
- e. Documents of elder brother and sisters.
- f. Non Availability Certificate.(NAC) from Maternal and paternal family.
- g. Only Father or Mother or sibling can apply in Sewa Kendra
- h. Utmost concerned SDM officer should decide such application rationally. Moreover none of them would have declared to the authorities that the applicant is already a regular student and had already passed his middle/ secondary education examinations.
- 37. Basically the main culprits are Concerned District Cricket Association Stakeholders as Jagmohan Singh secretary and Coaches DCA Mansa and even Punjab Cricket Association stakeholders for the following reasons:—
- a. Concerned DCA/ PCA primarily instigating the players to minimize their age, did not provide transparency or justice to competitor co-players/ co-teams.
- b. Moreover there is no any supervisor authority above BCCI/ PCA and they are not accountable to anyone. If any parent approached them on their official email for any grievances they don't bother even to respond.
- c. DCA's did not have any website, access to information must be open from which co-players or their parents could verify or look into the eligibility criteria certificates of co-players.
- d. Even the players who had found positive in TW3 Bone test while their selection of under-16 Cricket team should be allowed to play only in Senior Men's BCCI tournaments only. But these Calcket associations are further again allowing them to play in age limit group tournaments
- e. Cricket coaches and cricket association stakeholders should be disqualified from cricket activities who found guilty in committing any wrongdoing in the process.
- f. Punjab Cricket Association must be making record visible and easily assessable for all, of players Saksham Mittal @ Saksham Kumar, Shubham Singla, Jaspreet Singh @ Jasprit Singh, Kuldeep Singh and any other player who had played/ registered with their multiple given DOBs which are duly attested by DCA Mansa Secretary Sh Jagmohan Singh. I sincerely doubt that either PCA itself or some of its employees due to their alleged involvement in these

wrongdoings or PCA employees are trying to help Jagmohan Singh secretary and Coaches DCA Mansa.

- g. How PCA could not supervise the activities of DCA Mansa Secretary who is not providing opportunity to Mansa resident players and registering players only from other states/ districts and most of them are overage.
- h. Punjab Cricket Association should discourage registration of players having birth certificates created by following delay/ late birth registration procedure. Surprisingly 80% players are being registered who are having birth certificates registered by following delay birth registration procedure instead of regular birth registration.
- i. Randeep Singh Rajasthani players had been banned by BCCI. Copy of Ban order is annexed herewith as **Annexure P-45**. According to Ban order, Randeep Singh Rajasthani player was registered in 2019-20 session for U-19 team with Rajasthan Cricket Association with date of birth 01/11/2003. Birth certificate mentioning DOB 01/11/2003 had been issued on 2018 by following 'Delay Birth Registration Procedure.' How PCA / BCCI could allow him to play in 2021-22 session for U-19 age group team? Due to delay birth registration, Randeep could not be allowed to continue playing in U-19 team (2019-20, 2020-21, 2021-22) and last year session 2022-23 was his fourth year also. While Rules of BCCI only allows to play 2 years in U-19 for players registered with late entry. Just player has been banned but concerned District Cricket Associations are not
- j. Similarly is the case of Uday Saharan who had registered his birth certificate in 2016 by following delay birth registration procedure after a period of 13 years date of birth on 08/09/2004 and he had already played U-19 age group in sessions 2020-21, 2021-22 & 2022-23. With delay birth registration, how he could continue playing for State U-19 fourth year session 2023-24 for which he had attend NCA Camp this year. While Rules of BCCI only allows to play 2 years in U-19 for players registered with late entry. It means PCA & DCA's are clearly violating rule of law.
- k. Defaulter Cricket player Shubham Singia represented Mansa District (even though his name was also as suspect in FIR No. 61/2023 PS City-2 Mansa) school record mentioning multiple date of births already intimated to DCA Mansa & PCA Mohali, Similarly Multiple Birth Certificates of Aryan Yadav representing District Patiala Team became viral on social media & school record of Harish Kumar mentioning multiple date of births are intimated by different parents of district Moga. But concerned DCAs did not bother at all and both concerned DCA and PCA Mohali are approving them to continue playing with their multiple DOBs.

It is submitted that:-

1. As an affected parent regarding the above wrongdoings I had filed a complaint to SSP office Mansa (vide UID 100 94465 dated 30/12/2022), SSP Mansa referred the above complaint to DSP Detective Mansa ShLovepreet Singh for enquiry. After detailed enquiry by DSP Detective Mansa Sh. Lovepreet Singh, a case FIR No. 61 dated 7/3/2023 u/s 420/465/471/120-B IPC registered in PS City-2 Mansa against Jagmohan Singh Secretary DCA Mansa and three cricket

your from

players Randeep Singh, Saksham Mittal & Jaspreet Singh. Copy of FIR is annexed herewith as Annexure P-46 and its true translation as P-46/T.

- After registration of FIR, till date the accused Jagmohan Singh is continuing to work as Secretary District Cricket Association Mansa and organized inter district tournaments. State Camps and even after registration of FIR he dared to allow playing to the defaulter players like Shubham Singla, Aditya Balana etc. and even they were being further approved by PCA Mohali also.
- Earlier I had sent 3 emails on dated 12-03-2023, 17-06-2023 & 16-09-2023 to the President, Secretary and CEO of PCA Mohali and apprised them the present scenario of District Cricket Association DCA Mansa and about wrong approval of Shubham Singla who was otherwise absconding due to registration of FIR.
- Even on 20/3/2023, I sent the written complaints regarding the latest averments PCA Mohali through registered post.
- During the Police enquiry it came to highlight that the record of DCA Mansa 5. regarding details and registration of players in recent years had been intentionally misplaced by the accused Jagmohan Singh secretary DCA Mansa.
- The school authorities involved in whole process should be enquired about their role that how they had admitted the players without getting previous school record. Whether Coaches or DCA executives pressurized them to give admission without getting their previous school record.
- To make an High Level inquiry about my submissions and to investigate 7. the matter properly against Secretary & Coaches of DCA Mansa I request you that you should collect the proper evidence from PCA Mohali and scrutinize the following record:-
- Saksham Mittal @ Sakshamkumar was member of winning Mansa Cricket a. U-23 team in 2017-18 and on 18/11/2017 Mansa U-23 team had won against DCA Faridkot Cricket team. So PCA Mohali should send record that
- i. Whether in session 2017-18, Saksham Mittal was member of Mansa Cricket U-23 district team or not. The documents (birth certificate, Aadhaar Card and school certificates) submitted by Saksham Mittal in session 2017-18 and what was his player id at that time, must be collected.
- ii.In 2021-22 session as U/23/25 cricket team registration on behalf of which documents he was selected in U/23/25 2021-22 state Camp.
- iii.Total correspondence on behalf of which Sakaham Mittal had been shifted from U23/25 state team to U/19 Cricket team and duly attested by accused Jagmohan Singh secretary at that time of registration.
- iv.Saksham Mittal PAN No. ENKPM1072D and SBI Bank account No. 20333999479, IFSC Code SBIN0001735, player id in BCCI is 17674, how much emoluments/ stipend had been provided to Saksham Kumar @ Saksham Mittal through PCA Mohali.

v.In addition to 2017-18 and 2021-22, in which yearly sessions Saksham Kumar or Saksham Mittal had been registered with PCA.

- vi.Whether as per PCA record, it could be proved that Saksham Kumar or Saksham Mittal had played with his both date of births— 4/4/1997 and 4/9/2003.

- i.Whether Randeep Singh had played as guest player in DCA Mansa team.
- ii.At the time of registration of Randeep Singh with DCA Mansa for what reason NOC of Randeep Singh had not been asked?
- iii. Whether BCCI objected the candidature of Randeep Singh?
- iv.Rajasthan Cricket Association had issued show cause notice to Randeep Singh regarding discrepancies in his dates of birth whether PCA Mohali does not know about it.

- iii.On 12/12/2019, Jagmohan Secretary himself had displayed on his Facebook timeline that in the inter-district tournament 2019-20, DCA Mansa U-19 Cricket team had won against District Sangrur team and hence qualified for final tournament. Whether Kuldeep Singh was registered DCA Mansa U-19 Cricket team or not on 12/12/2019.
 - e. Record should be collected regarding ShubhamSingla:-
- i.In 2015-16 session whether ShubhamSingla was registered as U-16 DCA Mansa team member or not. Collect the copies of documents submitted by ShubhamSingla at the time of his registration in 2015-16 session as U-16 DCA Mansa Cricket team.
- ii.Whether on 14/11/2015, inter district tournament match between DCA Mansa & DCA Bathinda team was organised or not and whether DCA Mansa had won that match against DCA Bathinda.
- iii.How many yearly sessions, ShubhamSingla had been registered as district team member of DCA Mansa. Collect copies of the documents submitted by ShubhamSingla and duly attested by Secretary DCA Mansa.
 - f. PCA Mohali must satisfied with the above averments that Jagmohan Singh secretary DCA Mansa had allowed to play many players with both their original & fake dates of birth. Also he allowed many out of state players in District Matches initially without taking NOC from players' parent Cricket Association. Moreover he has been holding the Designation of Secretary of DCA since its affiliation with PCA Mohali so he is widely responsible for every wrong doing of DCA Mansa.

- g. Why PCA and other District Cricket Associations should not be made responsible for not providing transparent atmosphere to Punjab resident players as most of the players in recent Punjab teams are non residents of Punjab.
- h. Kindly check DCA Mansa record how many other players had been allowed to play by Secretary and Coaches of DCA Mansa with their both original as well as fake dates of birth. It should be extended to all District Association's of Punjab.
- i. DCA Mansa Coaches Hardeep Sharma, Bhagwan Singh, and Vinaypal Singh Gill are equally responsible for the same wrong doings, all these three coaches managed to bring players from other State and other academies at Mansa, even Coach's keep the players at their own homes and Coaches help players in question to get Aadhar and Voter cards at the Coaches home address.
- j. It is a bitter truth that the Selectors, Coaches of Punjab Cricket Association and Concerned District Cricket Association are well aware about the age difference of players overage, and they make those players as privileged players for Punjab Camps as well as representing Punjab Team.
- k. In the present year U-16 inter District Matches two players of one each of DCA Mohali and DCA Amritsar found overage, both players initially banned by PCA, both teams were banned for 2 years and both Associations fined by 25000/- each, Newspaper cutting attached herewith as Annexure P-47 & P-48. Later after few months a decision has taken in Apex Meeting that these players were allowed to play even after imposing the ban by PCA. If a player found overage he must be banned immediately.

So there was no other option remain with me except to file this Compliant with the prayer to the Hon'ble Ombudsman:-

- 1. To stop those players playing after made their Date of Birth Certificate with late entry and delayed registered players must be allowed only as per BCCI Rules only.
- To de-affiliate District Cricket Association Mansa with PCA due to alleged wrong doing since last many years.
- 3. To remove the life membership of Jagmohan Singh Secretary DCA for his involvement in enhancing out of state players with age frauds.
- 4. To remove all these three coaches of DCA Mansa who had motivated out of State Players to come to Mansa and play for Punjab by changing their documents and ensuring their admissions in local schools. Residence proof of many such players are at Coach's homes.
- 5. To help Mansa Police to properly investigate the case to nominate other accused.
- 6. Before start of this year BCCI State Tournaments, to easily trace out multiple DOB,s, ADHAR CARD updation of all players registered with Delayed Date Of Birth Registrations must be checked through OTP of their registered Phone numbers Or should seek record from UIDAI for all the ADHAR Card updation of players who are having registered with Delayed Date of Birth Registrations. By this every alteration in Aadhar Card regarding Date of Birth,

both original Date of Birth and lately entered Fake Date of Birth can easily be traced out.

7. Concerned record should be collected and investigated, which is easily available electronically on the official emails of PCA sent by DCA Mansa, could prove that accused Saksham Mittal, Jaspreet @ Jasprit Singh, ShubhamSingla, Kuldeep Singh & other players had been allowed to play with their both original as well as fake date of births

It is therefore humbly submitted that a strict legal action should immediately initiated to protect the future of Youth, genuine and resident players of Punjab, Putting up Ban on players playing Overage, registered through Delayed registration of birth late entry, all these players birth found to be registered previously. Kindly take strict action against District Cricket Association Mansa regarding de-affiliation with PCA and also make detailed report against other defaulter District Cricket Associations of Punjab State who had illegitimately enhanced playing of overage Players registered with late Registration Process who had been already studying as regular students in Punjab and other States. I also request you to prohibit them strictly so that in future no such player is allowed to play who is registered by following the procedure of "Delay Birth Registration" and Punjab Born players must be given their due share in Punjab Cricket Teams.

Moreover Punjab Cricket Association is solely responsible for cricket in Punjab and all district cricket associations assist in its work. To have everything crystal clear in selection of players, parents rely on Ethics Officer cum Ombudsman as you are the only ethics officer who has legal authority also to check discrepancies in working of PCA and District Cricket Associations. As PCA is running like closed system without displaying information about selected Cricket players in different age groups, so I request you to kindly issue directions to provide everything about registered players on PCA website. It must include parents AADHAR Cards and Class Ist to 10th class school certificates of players. Moreover PCA has an area of operations in Punjab and if Punjabi players are being ignored then it would be hampering growth of Cricket in Punjab. You should facilitate an environment for parents and budding players by banning all age frauds.

To save the larger Public Interest I humbly request you to have proper inquiry about every issue raised by me in my application and also request you that please help parents as if we raise such issues we are termed as whistle blowers and in return our wards are widely ignored for selection in various teams. I demand that PCA being a cash rich body must have a framework to identify Age Frauds and also allow parents to help PCA in detecting such frauds.

- 1.Sh. Anurag Thakur, Union Minister of Sports and Youth Affairs, India, Sir Kindly take action to Control Serious age Fraud in PCA and other States as well, If such frauds are ever came in knowledge of ICC as players Uday Sharan (who is ready to play State U-19 fourth year while his DOB is late registered and BCCI only allows 2 years to play in U-19 in such cases) and Randeep were likely to be part of Indian Under 19 squad for World Cup, it will bring a big disgrace for Indian Cricket as well as Nation.
- 2. Sh. Abey Kuruvella, General Manager, BCCI, Sir BCCI affiliated unit PCA and its Affiliated District Cricket Associations are promoting overage. Players who play in other States usually come to play after U-16 and directly play in Under 19 age category as they had already played with their original age in their parent State Cricket Association. But when they play for Punjab or any other State they always come up with new age proof and changed ADAHAR Card. It becomes too difficult for any parent to find out original DOB Certificates of faulty players, BCCI asks only to show two DOB certificates as age to be proof. So kindly have serious look into my submission as recently the issue has come up in Jharkhand Cricket Association as 26 years players were found playing in Under 19 age category mostly of them are players of other States.
- 3. Sh. Shabir Khandwawala, Chief Anti Corruption Unit, BCCI & Sh. Hardayal Singh Champawat Anti Corruption Unit, BCCI, Kindly take a quick action before start of this year BCCI interstate Tournaments ahead.
